1. Elmwood High School students are permitted to **bring one (1) guest of high school status**. Guests that have graduated from high school are permitted to attend special events such as Prom.
2. Once you arrive at the dance/activity, you must enter the building and remain inside until the dance/activity is over. **If you want/need to leave early YOU MUST NOTIFY me and I will call your guardian.**
3. All guests may be asked to show his/her driver's license or ID prior to admittance.
4. Once you have left the premises, you will not be permitted to return.
5. If you arrive late you may be denied admission.
6. There is to be no tobacco use at the dance/activity or on school grounds (smoking, vaping, chewing, etc.).
7. Any student or guest shall not possess, use, transmit, sell or be under the influence of any drug or alcoholic beverages of any kind before the dance/activity, during the dance, or on school property.
8. The Elmwood school administration and/or advisor reserves the right to remove any student and/or guest from the dance/activity or from school property.
9. The administration and/or advisor reserves the right to deny entrance to any student and/or guest.
10. I understand that attendance to a dance/activity at Elmwood is a privilege and not a right.
11. I understand that law enforcement officials and/or school officials will enforce these rules, regulations, policies, and procedures.
