#### 1. Primary Source

Definition: Original documents or objects created during the century.

time period being studied.

Example: The Declaration of Independence (1776), a diary from World War II, or a Roman coin.

# 2. Secondary Source

Definition: Works that analyze, interpret, or summarize historical events, often using primary sources.

Example: A history textbook or a biography of Abraham Lincoln.

## 3. Historiography

Definition: The study of how history is written and how interpretations of events change over time.

Example: Comparing how different historians view the causes of the French Revolution.

## 4. Chronology

Definition: The arrangement of events in the order they occurred.

Example: A timeline of the American Civil War (1861–1865).

#### 5. Bias

Definition: A preference or prejudice that influences historical accounts.

# 6. Archaeology

Definition: The study of past human societies through material remains.

### 19. Cold War

31. Hegemony

Example: Annexation of Texas (1845).

37. Pax Romana

Definition: A period of Roman peace and stability (27

BCE-180 CE).

Example: Emperor Augustus' reign.

38. Schism

Definition: A formal split within a religion or organization. Example: The Great Schism (1054) dividing Christianity into

Catholic and Orthodox.

39. Mercantilism

Definition: Economic policy where colonies enrich the

44. Luddite

Definition: Protesters against industrial automation (early

19th century).

Example: English textile workers destroying machinery

(1811-1816).45. Realpolitik

Definition: Politics based on practical goals, not ideals.

Example: Otto von Bismarck's unification of Germany.

46. Theocracy

Definition: Government ruled by religious leaders.
