

**GVB "THE BLOCK PARTY" SAND VOLLEYBALL TOURNAMENT
LIABILITY WAIVER, RELEASE & INDEMNIFICATION AGREEMENT**

IMPORTANT: THIS IS A LEGALLY BINDING WAIVER OF LIABILITY AND RELEASE OF CLAIMS, INCLUDING NEGLIGENCE. READ CAREFULLY BEFORE SIGNING.

The undersigned participant, or parent/legal guardian on behalf of a minor ("Participant"), agrees as follows:

1. RELEASED PARTIES - I agree to release, indemnify, and hold harmless **GVB, GVB Booster Club, The Strand (including its owners and affiliates), Grapevine-Colleyville ISD (GCISD), and all officers, directors, employees, volunteers, coaches, agents, and affiliates** (collectively, the "Released Parties").

2. ASSUMPTION OF RISK - I understand that participation in or attendance at the **GVB "THE BLOCK PARTY" Sand Volleyball Tournament** involves **inherent risks**, including but not limited to injury, illness, heat-related illness, paralysis, death, and property damage.

I VOLUNTARILY ASSUME ALL RISKS, known or unknown, including those arising from the **ORDINARY NEGLIGENCE OF THE RELEASED PARTIES**.

3. RELEASE OF LIABILITY - To the fullest extent permitted by Texas law, I **RELEASE, WAIVE, AND DISCHARGE** the Released Parties from **ANY AND ALL CLAIMS**, known or unknown, arising from participation in or attendance at the Event, including claims based on **ORDINARY NEGLIGENCE**.

4. INDEMNIFICATION - I agree to **INDEMNIFY, DEFEND, AND HOLD HARMLESS** the Released Parties from any claims, damages, or expenses (including attorney's fees) arising from my participation, or my minor child's participation, in the Event

5. WEATHER & EVENT CONDITION - I understand this is an **outdoor event** with risks including heat, weather, and uneven or shifting sand. Event organizers may **modify, delay, or cancel** the Event at any time for safety reasons. I assume all risks related to these conditions. **No refunds are guaranteed.**

6. MEDICAL AUTHORIZATION - I authorize emergency medical care if needed and accept full responsibility for any associated costs.

7. MINOR PARTICIPANTS - If signing for a minor, I certify that I am the legal parent/guardian, grant permission to participate, and agree to all terms on behalf of the minor.

8. MEDIA RELEASE - I consent to photography and video recording and grant permission for use of my (or my child's) image, name, and likeness for promotional purposes, without compensation.

9. GOVERNING LAW - This Agreement is governed by the laws of the **State of Texas**. If any portion is invalid, the remainder remains enforceable.

10. ACKNOWLEDGMENT - I have read and understand this waiver. I am signing voluntarily and understand that I am **WAIVING LEGAL RIGHTS**, including the right to sue.
