

TOWNSHIP OF SEREMBAN 2 BY IJM LAND

PHOTOGRAPHY CONTEST RULES & REGULATIONS

1. ELIGIBILITY

1.1 This contest is open to all Malaysians and permanent residents (with a residing address in Malaysia) as of 1 November 2022.

The two (2) categories of this contest are:

1.2 OPEN – aged 18 years and above as of 1 January 2022.

1.3 STUDENTS – below the age of 18 as of 1 January 2022.

2. CONTEST PERIOD

2.1 This Contest shall be held (3 calendar months) from 12:01 am on Tuesday, 1 November 2022, to 11:59 pm on Tuesday, 31 January 2023.

3. THEMES/SUBJECTS

3.1 TOWNSHIP OF SEREMBAN 2 shall be the theme for the duration of this contest for the above two (2) categories.

3.2 Any subject that will portray or interpret the view of the present-day daily happenings within the Seremban 2, such as; Lifestyle, Work, Recreation, People, Nature, Homes, Architectural Studies, Heritage, Food, The Environment (street, township, landscape, skyscape), or a moment of the day can be submitted as entries.

4. SUBMISSION FORMAT OF IMAGES

4.1 Images captured by any brand of cameras (using film or digital), including mobile phones, drones can be of any format (including panoramic), in color or monochrome (black and white). Images must have not been submitted before in any contest or event and have won any prizes given to them. The image/entry posted has to be in the form of a single image. No composite of images. NO WATERMARK or any form of photographer's identification or copyright mark on the image is advised. Any WATERMARK image/entry will be automatically disqualified.

4.2 Any form of digital imaging (including sepia and monochrome) or image retouching (including HDR and IR) is allowed. Image cannot be digitally manipulated such that image will be deemed unrealistic and untruthful with mobile retouching apps. Organizers/Judges of this contest reserved the right to reject the level of any manipulation of an image submitted to be allowed.

All shortlisted images/entries may be required to submit to the Organizers upon notice the digital file of high-res photos posted in the ORIGINAL FULL RESOLUTION (File Size up to 20MB of image data per submission) with complete EXIF data through email for verification purposes, failing which the entry will be automatically disqualified from the final judging. The Organizers may also, at their discretion, request the submission of a RAW file image, if applicable. As for pictures taken by mobile phones, the drone requires a minimum of 5MB file size for compliance OR Image Data file format JPEG/150dpi is recommended.

5. ENTRY PROCEDURE

5.1 There is no limit of images (entries) to the number of postings for the two (2) categories mentioned above (Clause 1.2 & 1.3). Submission of images (entries) must be taken from 1 November to 31 January, 2023.

5.2 Images/entries for the OPEN CATEGORY are not allowed to resubmit/enter for the STUDENT CATEGORY and vice versa. Students' submission (entry) to this contest are strongly advised to seek consent of participation from their guardians or the school's Principal.

5.3 A participant/ photographer is strongly advised to register and to post under 1 (one) name and NOT to create more than one (1) proxy or "second name" post or to use the image(s)/entries of others. Repeated posting of the duplicate image/entry or cross-posting on a non-related theme/subject(s) is strongly not advised. Failure to adhere to this rule will automatically disqualify a photographer/entry from the final round, judging if you are a shortlisted photographer.

5.4 Where applicable, the participant/photographer must hold a model release for the model(s) included in the image(s). Should any subject person be a minor (Age of Majority Act 1971- below 18 years old), to be included in the image(s), consent must be obtained from the parent /guardian to use the image(s). Should the participant/photographer fail to fulfill this clause, shall indemnify the Organizers for any damages incurred.

5.5 Participant /Photographer shall not submit any pornographic, obscene, political, criminal, or adult themes, links, cultural or race discrimination, or image(s) that, in the Organizer's sole opinion, is/are offensive.

6. JUDGING & RESULT

6.1 For both categories, a panel of invited judges together will make their picks to shortlist the images and to judge and award points to each shortlisted image/entry (photographer). The final results for the winning participants/photographers shall be based on their total overall awarded contest points for /her images submitted after the closing date, 31 January 2023.

6.2 Winners are to be rewarded as follows:

6.2.1 OPEN CATEGORY

(a) Top three (3) Winners:

Each is to receive a cash prize of RM3,000, a Nikon Z fc Mirrorless Classic body with NIKKOR Z 28mm f/2.8, worth RM5,648, and certificate.

(b) Five (5) Consolation Winners: Each is to receive a cash prize of RM1,000 a SanDisk portable SSD (1TB) worth RM1,726, and certificate.

6.2.2 STUDENT

(a) Top three (3) Winners: Each is to receive a cash prize of RM1,500, a Nikon Z 30 Mirrorless body with NIKKOR Z DX 16-50mm f/3.5-6.3 VR, a SmallRig Tripod (Remote control for Vlogging) worth RM3,918, and certificate.

(b) Five (5) Consolation Winners: Each is to receive a cash prize of RM800, a SanDisk portable SSD (1TB), worth RSP RM1,726, and certificate.

7. A participant/winner can only win one (1) prize. Prizes are non-transferable, and prizes in kind are non-exchangeable for cash and may be subject to availability. The Organizers – collectively the property developer IJM LAND SEREMBAN 2 and/or its Subsidiaries, V TEAMPRO VENTURES, NIKON, FUTUROMIC PHOTO AV SDN. BHD., the collaboration partners, sponsors, agents, and the management committee of this photo contest and exhibition reserve the right to substitute any prizes in kind with items of equivalent value without prior notice.

7.1 The organizers also reserve the right not to award any prizes for any category of winners if the entries are below the judges' and the organizers' expectations.

8. All shortlisted winners are also required to submit their Full Name (as in new I/C or Passport) and new IC/Passport No/ Student's I D, postal address, email, and telephone/mobile number within the stipulated date stated in the Organizer's email, notifying the said participant's entry being shortlisted.

9. The contest results will be decided by a panel of judges appointed by the Organizers. The judges' decision is final, and no correspondence will be entertained.

10. COPYRIGHT & REPRODUCTION

10.1 The rights to use images shall be indefinite from the date the results/winners are announced. Credit shall be given for a photo and video

(collective photos) posted on social media (Facebook, IG & U-Tube); you agree to be bound by the terms and conditions as per para 4.3 above.

10.2 The participant/photographer hereby grants the organizer a perpetual non-exclusive royalty-free license to the Organizers collectively IJM LAND SEREMBAN 2 and/or its Subsidiaries, V TEAMPRO VENTURES reserve the absolute rights to exhibit or reproduce any acceptable images (entries) in whatever way deemed fit for exhibitions and any print-based publicity. All entries are non-returnable and the Organizer shall be permitted to reproduce, exhibit, publish or otherwise reuse the photograph(s) submitted in the contest without giving the participant/photographer prior notification or getting the participant's prior consent for promotional purposes or fee payment to the entrants, regardless of whether the participants/photographers are winners or non-winners of this contest.

10.3 The Organizers collectively IJM LAND SEREMBAN 2 and/or its Subsidiaries, V TEAMPRO VENTURES reserve the absolute rights to accept/reject your work (image(s)/video(s) to be reposted/shared on all social media (Facebook, IG & U-Tube) platforms that we manage, operate, and own solely and collectively.

10.4 By participating in this contest, participant/photographer agree to be bound by these rules and regulations and the decisions made by the Organizers and the panel of judges. In addition, they have read and understood the laws and restrictions stated above and will adhere to these rules and regulations. The participant/photographer undertakes that he/her owns the submitted photograph(s) and the whole copyright in the work vested in the photograph(s). In this respect, the participant/photographer further undertakes that the submitted photograph(s) shall not infringe or

violate any copyright, trademarks, contract's right, passing off or any other intellectual property rights of any third party or entity or violate any other person's rights of privacy or publicity or any applicable law. The Organizers shall not be held responsible in any way whatsoever for infringement or violation of any copyright, trademarks, contract's right, passing off or any other intellectual property rights of any third party on the submitted photograph(s).

11. PRIVACY NOTICE
