### **Process to Apply**

#### 1. Apply to Collin College via ApplyTexas - USE YOUR PERSONAL EMAIL

If you plan to take dual credit classes this summer **or** start in the fall, go ahead and complete the **Summer 2026 application** now.

- Create an Account: Visit ApplyTexas.org and set up your account using a personal email address (not a school email address).
- Start a New Application:
  - Select "Two-Year Community/Junior College".
  - Choose "Collin College (McKinney)".
  - o For "Admission Basis", select "Non-Degree Seeking".
  - o Choose the appropriate term (e.g., Fall 2025 or Spring 2026).
    - If you plan to take dual credit classes this summer or start in the fall, go ahead and complete the Summer 2026 application now.
    - If you decide not to take summer classes, no problem—your summer application will still count for the fall semester.
    - If you already know you'll start in the fall and won't be taking summer classes, complete the **Fall 2026 application** instead.
- **Submit the Application**: There is no application fee. After submission, you should receive a confirmation email from ApplyTexas.

#### 2. Activate Your Collin College Account

- Receive Credentials: Within three business days, Collin College will email you your College Wide ID (CWID) and your username. This is what you will use to set up OneLogin!
- **Set Up OneLogin**: Use the provided credentials to access OneLogin. (See below)
- **Complete Safety Training**: Log in to OneLogin, navigate to Workday to view and complete the training.
  - Once WorkDay loads, scroll down, and you should see an option to complete safety training. Click on the box in the upper right-hand corner for tasks.
  - After clicking on "Safety Training," a red hyperlink will appear on the left. Click on the red hyperlink, and the safety training slide show will start.
  - Make sure to hit 'next' twice after completing the quiz; you will want to continue until you return to the Collin main webpage.



# Setting Up OneLogin On Your Smartphone

You will need both a computer and smartphone for this setup




#### **IMPORTANT:**

You must have a passcode on your smartphone to use the OneLogin App. To setup a passcode on your device, refer to your device's operations manual.

Login to https://collin.onelogin.com/ with your Collin username and password. When prompted, click on Begin Setup

On a Computer Click on Activate




On Your Smartphone Open OneLogin Protect App

Click on the + to add your first account






You may be prompted to add the OneLogin extension to your browser. You can select Add OneLogin extension (if available) or select skip





#### 3. Submit Required Documents

• **Dual Credit Permission Form**: Complete this **FORM** and email it to Ms. Thrash at sarah.thrash@communityisd.org

#### 4. Registration

• Once you have met the testing requirements, completed the ApplyTexas application, and returned the permission form, email Ms. Thrash at <a href="mailto:sarah.thrash@communityisd.org">sarah.thrash@communityisd.org</a> to select the classes you wish to take.

#### 5. Payment

Note: If you qualify for **free or reduced-price lunch**, your **dual credit tuition will be completely covered**. You'll only be responsible for any additional costs, such as textbooks, supplies, or other required tools.

Tuition and Fees: Pay any applicable tuition and fees through the Workday system.

- 3-Hour Course = \$203 + First Day Access (FDS) Book (if required)\*
- 3-Hour Course for students who qualify for free or reduced lunch = First Day Access Book (if required) ONLY\*
  - \* Additional fees may apply
    - The following non-exhaustive list includes courses that tyically have an FDS Book:
      - Math
      - Sciecnce
      - Economics
      - Historu
      - Business Courses
- Online Payments can be made through your Collin OneLogin platform. Once you're logged in, select "Workday" then "Production." Under student, select "Financials Hub". Under Suggested Links, select "Transact Payment"

#### 6. Textbook & Supplies (NEW)

Starting this **spring semester**, all Collin students will be part of the **Barnes & Noble First Day Complete** program.

#### Here's what that means for you:

You'll be charged a flat rate of \$23 per credit hour, and that covers all your textbooks — no matter the price of each individual book.
 You can opt out if it ends up being cheaper to buy your own books. Barnes & Noble will give you a calculator to help you compare.

You'll be able to **opt in or out** until a specific date (to be announced).

#### Important notes:

- Supplies like scrubs or lab kits aren't included.
- Most books will be digital, so you'll have them on the first day of class.
- If your schedule changes, your book access automatically moves with your new class no need for refunds or reorders.
- Every student in the same class pays the **same textbook cost**.

Some instructors might still choose a physical textbook outside the program (for now). The cost will show up in your **tuition and fees**, so don't be surprised if that total looks a little higher.

This new setup is designed to save money, reduce stress, and make sure you're ready to learn from day one.

#### 7. Prepare for Classes

• **Explore Resources**: Take advantage of student services, including tutoring, library access, and counseling. (Collin College)

#### 8. Ferpa

 Parents, if you wish to access information on your student's progress, billing, or general questions, your student must complete the FERPA in OneLogin, and they must add you. This is the only way Collin will provide any information you're requesting!


