Master Electrician - Welcome	Welcome to the Online Master Electrician Application. Before you begin, please review the important information below: There are two methods you may use to become licensed. To apply by one of the available methods you will have to have already completed, or have in your possession verification of the below. Please review the Electrical Licensing Guide for more detailed information on requirements. NOTICE: Criminal convictions must be reported on every application, even if they have been previously reported. Failure to do so may delay the processing of your application. <u>Master Electrician by Examination</u> - Completed one of the following: 10,000 hours of electrical experience in no less than 5 years. If you have not obtained this experience yet, do not apply. 8,000 hours of electrical experience in no less than 4 years AND hold a community college or trade school degree in an electrical construction field. 2,000 hours of electrical construction experience AND hold a degree in electrical engineering from an accredited college or university. - Have achieved a passing score on the Colorado Master Electrician examination administered by PSI Testing. If you have not achieved a passing score yet, do not apply. <u>Master Electrician by Endorsement</u> - Hold or have held an active, state-issued license as a Master Electrician or equivalent in another state issued by an examination on the current National Electric Code (NEC) in use in Colorado at the time of application. If you do not currently hold an equivalent electrician license, do not apply. - The current NEC code in use in Colorado is the 2023 NEC. - Completed 10,000 hours of electrical experience in no less than 5 years. If you have not obtained this experience yet, do not apply. Basically, if you don't have the above, it is best for you to wait until you can secure it. Otherwise you will not be able to qualify for a Master Electrician license. We'll ask more specific information later in the application about the above items. Remember, you can stop and cancel this application at any time before submitting. However, if you submit the application, pay the fee and do not provide the information as requested, submit incomplete documentation or do not qualify, your application may be rejected and <u>no refunds or transfers</u> will be given. Upload the Affidavit(s) of Experience completed by each employer to verify this experience. If you do not have this experience or cannot provide verification, do not apply.
