

WAIVER AND RELEASE OF LIABILITY (MINOR)

In consideration of my child _____ being permitted to enter and use the HUNTER RANCH GOLF COURSE located at 4041 Highway 46 East, Paso Robles, CA 93446, ("PREMISES"), owned by Hunter Ranch Golf Course LLC ("HUNTER"), I acknowledge and agree to the following:

My child will abide by all course rules, which are attached to this waiver and posted on premises.

I understand that there are inherent risks involved with my child's use of the PREMISES, including bodily injury, property damage, injury or damage suffered as a result of the acts or omissions of others (members of my party, other guests, or third parties).

I ASSUME THE RISK OF ALL LOSS, DAMAGE, INJURY, OR DEATH suffered by my child which may in any way arise from or be associated with the use of the PREMISES, and/or with the participation in any activities, at the PREMISES. I HEREBY WAIVE, RELEASE FROM LIABILITY, AND COVENANT NOT TO SUE HUNTER, ITS AGENTS, EMPLOYEES, OWNERS, OFFICERS AND DIRECTORS FROM ANY AND ALL LIABILITY RESULTING FROM OR ARISING OUT OF MY CHILD'S USE OF THE PREMISES AND/OR PARTICIPATING IN ANY ACTIVITIES AT the PREMISES. This waiver, release and covenant not to sue extends to any and all claims, demands, complaints, causes of action, costs or expenses (including attorney's fees), which I may have now or hereafter acquire, known or unknown, contingent or liquidated, of any nature whatsoever, including active or passive negligence, arising from or which in the future may arise from, any of the causes noted and/or any act or omission of any individual, whether owner, agent or employee of HUNTER, a third party, an independent contractor or another guest at the facility. This waiver, release from liability and covenant not to sue shall be binding on me and my child, and upon our heirs, personal representatives and all other successors in interest. It is intended that this waiver, release and covenant not to sue be interpreted as broadly and inclusively in scope as permitted by the laws of the State of California and the State of California shall be the forum for any lawsuit filed hereunder. If any part or provision of this document is held unenforceable the balance shall be given full force and effect.

I HEREBY ACCEPT FULL LEGAL RESPONSIBILITY FOR THE CONDUCT OF MY CHILD WHILE AT HUNTER and shall defend, hold harmless and indemnify HUNTER, its employees, agents, owners, officers and directors from any and all liabilities, damages to property or injuries sustained as a result of my child's use of the PREMISES and/or participation in any activities at the PREMISES.

I have carefully read this form, fully understand its contents, and sign it of my own free will. I verify that I am the Parent/Guardian of the child named on this form, that I have fully completed this form and that I have authority to enter into this form agreement. **This Agreement shall remain in full force and effect through December 31, 202____, unless withdrawn in writing.**
