- The dean approval deadline for spring '25 DEA has now passed, so please focus on fall '25. When revising an outline, update the DEA. If that seems like a silly thing to do now or next semester because you just updated or created your DEA, please contact Craig at the hair account: ccchair@ccsf.edu
- The curriculum timelines for AY 2024-25 will come out later this semester, but outlines and DEA will be in sync.
- Those of you waiting to revise recently expedited GE courses, feel free to work on drafts in CurriQunet, but please wait to launch. Give us a bit more time to get new outcomes language/mapping into place for you.
- The GE and Grad Requirement Subcommittee has been reviewing and updating gen ed learning outcomes (GELO) to be used in CurriQunet as part of the new Title 5 (2024) and Cal-GETC (2025) changes. This mapping needs to be in place for fall '24 so that GE courses can be aligned curricularly (Is that a word?) with GE outcomes expectations and so that assessment data can be gathered.
- That said, please do not forget about the [expiration spreadsheet](#) to stay on top of the 6-year cycle (approval date to approval date). And please remember that if a course has not been offered in 6 years, you should deactivate it. Run an Argos report. Remember to check the impacts of that deactivation because it may alter programs and prerequisites and trigger other outline updates. Or maybe you can think of a great way to modify it and make it even more appealing to students. But if it's not going to be scheduled, deactivate it and reactivate if there's demand for it. Reactivation of historical purses, like regular modifications, takes two semesters, so plan accordingly.
