Dr. Mateeva joined AUCA in 2005 an since then she has been teaching full-time since 2005. In 2012-2015 she served as the Head of International and Business Law Department, AUCA. Since 2015 she has been the Director of the LL.M. Program at AUCA. In 2024, she was appointed Head of the International and Business Law Program and head of the Law Division.
