Reviews of Results (RoR) services	Access to Scripts (ATS) services
RoR Service 1: Clerical Check What? A check that all parts of a paper have been marked, that the marks have been correctly counted and the marks on paper match the result – mark can go up or down. Why? Following a priority access to scripts request a student may feel some of their work has not been marked/that the marks have been incorrectly added together. Deadline - 23 September 2025	ATS: Priority Copy What? Copy of the marked paper. Why? To decide whether to request a review of marking or clerical check. Deadline - 20 August 2025
RoR Service 2: Review of Marking What? A review of the original marking of the paper, by a second examiner, to ensure it is free from error and represents a reasonable exercise of academic judgement. This includes a clerical check. Why? Student feels that their result is inaccurate. Deadline - 23 September 2025	ATS: Original What? The original marked paper. Why? To support teaching and learning. Deadline - 23 September 2025
RoR Service 2P: Priority Review of Marking What? A review of the original marking of the paper, by a second examiner, to ensure it is free from error and represents a reasonable exercise of academic judgement. This includes a clerical check. Why? Student feels that their result is inaccurate. Appropriate for students awaiting a place at university/other HE establishment. Deadline - 20 August 2025
