### **City DOT Projects**

An update on some [city DOT projects](#), such as turning outdoor dining areas into permanent sidewalks, and improvements to intersections to improve walkability and pedestrian safety. We noted the importance of reaching out to our membership to get letters of support for specific local projects if we need to apply for funding or grants. This will help the community understand what concrete improvements they can expect to see in their neighborhoods.

### **Board of Reps Advocacy Program**

Jerry discussed the [Board of Reps advocacy program](#), where we are trying to build relationships with our local reps. Some of our members have been talking to rep members who have been hostile to our priorities in the past - we want to develop a relationship with them, invite them to our happy hours, etc. to build bridges.

### **West Main St Bridge**

Robin gave an update on [West Main St Bridge](#) - the current plan is to build a bike/ped-only bridge a bit north of the current bridge. Hopefully it will be built by next year.

### **Housing Affordability Study**

The City of Stamford is currently conducting a [housing affordability study](#) to explore ways to deal with the local (and regional) crisis of housing unaffordability. ### **Partnering with other orgs**

Will and Dice discussed partnering with like-minded organizations across the state - so far we have had conversations with the [Safe Streets Coalition of New Haven](#), the leaders of bike/walk commissions in Norwalk and Fairfield, and we recently spoke to a local reporter who is interested in doing a video report about organizations like us and the fight for safe streets. ### **Stamford train station redesign**

Will is on a citizen advisory commission for the Stamford train station redesign, and we are trying to promote the need for better bike/ped infrastructure near the station and more transit-oriented dense mixed-use development, instead of the status quo of the station being a giant parking garage with some offices next to it. Unfortunately, recently Governor Lamont and the Connecticut Department of Transportation just broke ground

on a new 900-car garage - the state DOT is very much committed to reinforcing car dependency and car traffic. Part of our mission needs to be reforming the culture around these broken state institutions.

### **Happy Hour**

The monthly PFS Happy Hour will move indoors starting next month, rotating to new locations. Announcement to follow soon.

### **Meetings**

A decision was made to host PFS Strategy Meetings on a monthly basis given the growth of new members and topics. Jerry will send a Doodle poll to determine the best day of the month works best for the group. A decision was also made to host an annual Long Term Strategic Planning Meeting once a year to explore new ideas, assess our priorities, gain consensus, and set our goals. Targeting early December for that meeting to coincide with the new incoming administration.

### **Desegregate Connecticut**

Dice gave an update on the [Desegregate Connecticut](#) coalition of which PFS is a member. In the last legislative session the state passed an incremental zoning reform bill that legalizes ADUs (backyard cottages) statewide. In the next session the group will be looking to pass legislation to free up zoning around train stations in Connecticut, many of which have extremely restrictive zoning (multifamily housing bans) that wastes the economic and urban potential of these areas. Other proposals include reducing minimum lot sizes state-wide - excessively large lot size minimums (one acre or more per house) are one way in which localities try to exclude those of lesser means.

### **Op-ed**

We recently published an [op-ed in the Stamford Advocate](#) featuring our [Board of Reps scorecard](#). Our website got about 50-60 new hits from that article since it was published a couple of days ago.

### **Local e-scooter ban**

Will discussed the need to overturn Stamford's local ordinance that bans e-scooters. While the city is focused on expanding street infrastructure, it's a chicken-and-egg problem: people won't support bike/mobility lanes if people aren't biking or using scooters. We think it makes sense to legalize e-scooters, which will create the need for the infrastructure as more people use them to get around.

### **New mayor**

We discussed the importance of getting a meeting with the new mayor to discuss our priorities and get ahead of potential NIMBYism with respect to street infrastructure. Both candidates have expressed support for expansion of bike/ped infrastructure, although they are weaker on issues of housing/zoning reform.
