  - > 63022 Audit Presentation by Solutions
    - No instances of noncompliance were reported
    - Highest form of assurance was given
    - Financial conformities are all in line with what the State and GAPP require
    - Federal Program Audit ESSER Funds the bulk of the money was spent on audio visual and wages, all positive opinions given on the reporting process
    - The audit report is as clean as it can be, a huge thank you to Cara Wilber
    - SIA Update
      - The SIA Survey sent out received 393 responses
      - Public input and artifacts are the biggest contributors with safety, counseling, and mental health as high priorities to focus on funding next year
      - The proposed budgets were released last Friday for the High School Success Act and SIA Funds
        - High School Success Funds \$254,000
        - SIA Funds \$672,000
      - A Bond Survey was sent out last week which has pieces in it that touch on SIA funding
        - 131 responses have been received from the public and 134 within the district
        - The survey will be left open until the March Board Meeting
        - More advertising will be done so we can hopefully get more input from the public
