- I have sought and obtained consent from the parent or guardian of every Team Member participating in the Challenge and to grant to OpenUK (and its partners) permission and authorisation to take, record and retain any media which may form part of the entry to the Challenge ("Media") and, thereafter, to use such Media to: (a) promote, showcase and highlight Open Technology, the OpenUK Challenge, Digital Glove or micro:bit, (b) promote and illustrate Science, Technology, Engineering, Art and Mathematics (STEAM) subjects, and (c) to incorporate and publish such Media as part of OpenUK's or a third party's websites, any form of press, social media, promotional media or museum or other exhibitions, or other reasonable activities, other web content and other marketing and promotional materials (including print and displays) and on OpenUK's website(s) and/or related third party website(s), both in the United Kingdom and globally.
