Terms of Service

2025

By purchasing any artwork from me, you automatically agree to these following terms. Please read carefully, as I will deny your commission if it does not correspond with my terms of service. These terms are subject to change at any time. If you have any questions or concerns, feel free to ask my email: nightrizer.arts@gmail.com

- I have a right to decline a commission for any reason, especially if it goes against my terms.
- I retain all rights to my work, which include but are not limited to the right to use the artwork for self-promotion and upload it to any of my personal galleries or portfolio, unless otherwise agreed upon. I can do private commissions as well, so if you don't want me uploading the finished work to any of my galleries, please let me know beforehand.
- You may NOT use the artwork for commercial purposes unless otherwise agreed upon.
 - **You may NOT use the artwork for any sort of NFTs/Blockchain/cryptocurrency.**
 - **Additionally, you may NOT use the artwork for training AI.**
- You have the right to use your commission for any personal use you want (avatars, wallpapers, icons, profile pictures, upload it to your own personal galleries with credit given, etc.) just as long as it isn't for commercial use or you claim you created the artwork.

What I can do:

- OCs and fanart
- Animals
- Dragons and other fantasy creatures
- Humans, humanoids, and anthros
- Weapons, armor, and accessories
- Mild gore
- Simple machinery

What I will NOT do:

- Explicit nudity or anything sexual (NSFW)

- Racism, homophobia, transphobia, incest, pedophilia, etc. (basically nothing gross or dehumanizing)
- Cultural appropriation **(this includes feathers on characters heads/behind the ear as an accessory)** However, characters that have feathers growing on their heads naturally are ok (such as birds, or dragons with feather crests).
- Fetishes
- Extreme gore
- Very complex machinery
- Emulate another individual artist's style.
- (In general, I won't draw anything that I'm uncomfortable with, so you can always ask if you're not sure about something)

Process

- Please fill out a commission request form if interested (I post the link to the form on my social medias when open). The information I ask for in the form is:
 - references and/or detailed descriptions of the character(s).
 - what you want the character(s) to be doing.
 - The overall mood of the image.
 - If ordering an image with a painted background, let me know if you want a specific environment, time of day, or what the weather to be like in the picture.
 - Your email address for the invoice.
- Once your commission is approved, I will send you a thumbnail sketch to approve of soon after. Next, I will send you an invoice, and after you approve of the invoice and payment is received, I will begin work on your commission as soon as possible.
- Depending on the commission type, I may send you a cleaned up sketch to approve of before moving onto the lineart. Normally, I always send a WIP after lineart and color. For scenes, I sometimes send another WIP after this to show progress on detail rendering. If requested, I will show more WIPs of the progress.
- You may ask for a work-in-progress at any time.
- Once the image is finished, I'll send you a full resolution file (and a smaller, cropped version without the signature for scenes) of your image via Google Drive and upload the final image to my gallery on Deviantart. I may also post it to my other accounts on Twitter, Bluesky, tumblr, InkBlot, etc.
- **If you would like to keep the commission private, please let me know in the commission form before starting, and the finished work will not be posted publicly anywhere.**
 - I can also refer to you as anonymous if you want me to post the artwork.

Payment Process and Refunds

- Payments are made in USD via Invoices through Paypal, so your Paypal address is required to send the invoice.

- Payment is due upfront after an initial thumbnail sketch is approved. I accept payments in increments or payment plans depending on your circumstances (**More info on this below**).
- I should have your commission done sometime within a week to a month *after the rough sketch* depending on my queue, commission type, contact with commissioners, and life. Larger commissions may take longer than a month to complete.
- I cannot guarantee that I will finish your commission on a specified deadline. However, I will try my best to meet any reasonable time frame you have in mind.
- I do not offer full refunds as I can only refund work that was not done. However, if you feel you are unsatisfied with the final piece, I will offer a remake or partial refund depending on what type of artwork it is.
- You cannot change what you want your commission to be after approving the thumbnail sketch and sending payment. However, I accept up to three small edits.
- If you exceed more than three edits to a piece, I may charge an extra fee before continuing.
- Please do not send me any form of payment without my consent.

Payment plans

I accept payment plans on anything over \$300. Preferred payment plan time is one month, but I can extend it to three months, particularly for anything over \$500.

Payment plans are done through paypal invoices. I enable a multiple payments option, so whenever you want to make a payment, find the invoice in your email and pay through it.

If you plan on printing your commission....

Please let me know beforehand, and what the print dimensions will be. I will send you a CMYK color version PSD file just in case the printer you are using will need it. Due to print colors being different from digital colors, I cannot guarantee the colors will be printed accurately (that's mostly up to the printer you're using). Bright pictures are recommended for printing as they turn out better than dark images like night scenes (though I can still work with night scenes, they'll just be brighter than I usually make them). Lastly, I cannot print your commission for you as I don't have the means to do so right now.

Terms of usage for designs:

You retain all rights to the character of any design purchased from me, be it a custom or adoptable. However, I still retain the rights to the original *artwork* I've created. That means you cannot use the artwork I created for commercial purposes (like merch or prints) unless otherwise agreed upon.

What you can do:

- Upload the design/image to your personal websites/galleries.

- Use the character/design for anything you wish (original stories, roll plays, etc.)
- You can resell the design for whatever price you feel it is worth (**There are no requirements on how much you can resell it for**).
- I may keep or resell any rejected concepts if they are not claimed by the client.
(There is an extra fee for claiming more than one concept: see price guide)
