## Knujon

**Garth Bruen** is the Owner of **KnujOn**, which sees him focusing on anti-spam efforts. The name of the company is "No Junk" spelt backwards. He is also a member of various anti-spam and cyber crime organizations, such as the [Anti-Phishing Working Group \(APWG\)](#), [HTCIA](#), and [Infragard](#).

His anti-spam efforts are largely focused on shutting down the spammers websites through coordinating with their [ISPs](#) and [registrars](#), not on filtering or blocking, which he sees as options that effectively ignore rather than solve the problem. KnujOn has shut down more than 30,000 spam sites, and has been aided in this by Internet users who forward the organization their junk mail. The junk mail is used to create a database that links sites to known spammers.<sup>[1]</sup>

To promote healthy, independent, and engaged Native Communities through media access, control and ownership.


