The Federation of Malaysia and Association of Southeast Asian Nations  
Desiring to conclude an agreement relating to the federation;

Agree as follows:

*Article I:*

The Federation of Malaysia will be placed in a state of suspended animation and the responsibility of defence and foreign affairs will be handed over to the Association of Southeast Asian Nations.

*Article II:*

The Federation of Malaysia may continue her membership within the United Nations under the conditions set by the Association of Southeast Asian Nations.

*Article III:*

All agreements and treaties signed by the Federation of Malaysia shall continue to apply within the nation to ensure peace and order during this period of suspended animation.

*Article IV:*

The Malaysian Armed Forces and Royal Malaysia Police shall be dissolved in accordance with Article I as the defence of the Federation of Malaysia will be under the responsibility of the Southeast Asia Treaty Organisation

*Article V:*

This Agreement shall be signed in the English, Malay, Chinese and Tamil languages except that the Annexes shall be in the English language only. In case of doubt the English text

of the Agreement shall prevail. In witness whereof the undersigned, being duly authorised thereto, have signed this Agreement.

*Article VI:*

The administration group of the Federation of Malaysia may resume control of the group from the administration of Association of Southeast Asian Nations with prior authorisation from the Secretary-General and Chairman.

**ANNEX A**  
**SUSPENDED ANIMATION BILL**

**Section 1**

1. This Act could be named as Suspended Animation of the Federation of Malaysia 2019
2. This Act will come to effect on the date fixed by the Ministers and it will be announced to the public.

**Section 2**

**1. Establishment**

- a. All official activities and groups within the Federation of Malaysia will be suspended
- b. The sovereignty of the Federation of Malaysia shall be under the responsibility of the administration of the Association of Southeast Nations
- c. The role of Yang di-Pertuan Agong will still continue to act as the Head of State
- d. Citizens of the Federation of Malaysia shall continue to bear the same rights
- e. The administration of Association of Southeast Asian Nations may represent the Federation of Malaysia on global organisations.
- f. The Malaysian Armed Forces and Royal Malaysia Police will be demobilised and disbanded on the 17th March
- g. The Defence of the Federation of Malaysia will be under the responsibility of the Southeast Asia Treaty Organisation

**2. Powers**

- a. The administration of the Federation of Malaysia may continue to micro-manage the “[MYS] Malaysia)” ROBLOX group
- b. Selected officials from the Association of Southeast Nations will have authority to safeguard the sovereignty of the Federation of Malaysia
- c. Representatives that wish to represent the Federation of Malaysia on the United Nations must be selected by the administration of the Association of Southeast Nations.
