Summary

Testing has begun today on the W3C website on behalf of Studio 24. The session has consisted of checking the rendering and responsiveness of three templates of the W3C website across a variety of compatibility environments. Due to the pages not being linked to the back-end, functional testing did not take place today.

Overall, the templates performed well under test. The site is seen to be responsive to different screen sizes and the templates render mostly consistently across tested environments. The limited front-end functionality that is present on the templates has also been seen to work as expected, with the user being able to interact with the carousel and view embedded videos.

Four cosmetic issues were raised today, all of which are very minute. The most notable issue relates to the carousel current screen indicator not following the navigation. Additionally, on iOS mobiles the breadcrumb arrow was seen to be partly cut off, and the member company logo tiles were observed to render longer than expected on Safari browser. One of the cosmetic issues was raised as a suggestion to recommend that the positioning of the 'Ways to get involved' buttons is reconsidered to reduce empty space around them.

All in all, 4 cosmetic issues were raised today on the W3C templates. Testing is currently scheduled to continue Thursday 22nd April, where test planning for the full test execution will take place.
