Latest UAE Tourist Visa 2025 Rules and Categories

Planning to [travel to Dubai](#) in 2025? Please pay close attention to these [UAE Tourist Visa rules](#) for a better understanding of the situation and to plan better trips. First of all, the UAE issues different types of Tourist Visas, meant to accommodate different purposes of people.

You can find **UAE single-entry tourist visas** for 30 or 60 days. The **multiple-entry tourist visa** for 30 or 60 days is also really popular. There is a longer period in the picture. It is the **UAE multiple-entry tourist visa for 5 years**.

The **UAE visa on arrival** is meant for 30 days or 90 days, meant for different nationalities. There are **UAE visa on arrival for Indians**, too. On top of it, the **UAE eVisa for GCC residents** has been helping GCC residents explore the Emirates easily.

Last but not least, the [UAE transit visa](#) - meant for 48 hours or 96 hours. These are short-term visas, helping tourists explore a handful of UAE landmarks. For example, in 48 hours, you can get out of Dubai International (DXB), take the [Dubai Metro](#) from Terminal 1 or Terminal 3, or hail a cab. Next, check in at a hotel, take a bit of rest, leave your luggage there and get set go - for the grand exploration of Dubai. You can come to [Dubai Mall](#), [Burj Khalifa](#) and [Dubai Fountain](#) - all in the same area. Go check out a couple of traditional souks and indulge in some much-needed dining action at JBR. Your experience is going to be as memorable as it can be.

You can apply for UAE Tourist Visas through hotels, tour agencies and airlines, such as **Emirates, flydubai, Etihad and Air Arabia**. There are many licensed **travel agencies in Dubai** and **hotels in Abu Dhabi**, Dubai, Sharjah and more arranging visas. But there is a need to purchase the tickets through these entities and maintain bookings at the specific properties.
