**STAND WITH COLORADO WORKERS:** With the Trump-Musk administration's brutal attack on American workers, it is more important than ever to support our workers. **CO SB5, the Worker Protection Act**, would make it easier for workers to form a union. Colorado is the only state that requires 2 elections - the second with a 75% threshold - before workers can form a union. The Worker Protection Act removes that second, unnecessary and burdensome election. This makes it easier to get the benefits that come with a union contract; better pay, better benefits, and safety on the job. Governor Polis has threatened to veto this critical workers' rights bill.

**To DO:** Call Governor Polis and tell him to stand with workers, and sign SB5, the Worker Protection Act. 303-866-2885

Rally at the Capitol to protect Medicaid and other health programs: Join Center for Health Progress on the west steps of the Colorado Capitol on Wednesday, April 16, 11:30 am, (the day after Tax Day) to remind our representatives that we will continue to hold them accountable to what's best

for working people, and that our communities rely on vital services like Medicaid, SNAP and Medicare.

**Our message is clear:** You can't cut \$880 billion from Medicaid without terminating healthcare for 15 million people, including people fighting cancer, seniors in nursing homes, children, veterans, and people with disabilities. And these cuts do nothing to crack down on corporate greed and price gouging that's making our healthcare costs skyrocket.
