- Commissions ranging from General to Adult. Female will be General Audience only.
- Paw themes, Muscles, feminine males, transformation (muscle growth).
- If you are unsure of specific themes please inquire. (Just Ask!)
- There will be no discounts for the use of my characters in commissions. I reserve the right to refuse any commissions with the inclusion of my characters for any reason at any time.

WHAT I WILL NOT DRAW

• Sonic OC's, Humans, Bugs, Feral Characters, Cub/Child themes, Diapers, extreme hyper genitalia and muscles, hermaphrodite characters, macro/micro themes, MLP or related characters, Futa, Watersports, Scat, Flatulence, Mutilation, Gore, Gaping, Vore, etc.

IF YOU ARE UNSURE OF CERTAIN ASPECTS OF A COMMISSION

• If you are unsure of a specific theme that I have not listed above, please inquire about your specific theme, character or scenario.

WHEN WILL MY COMMISSION BE DONE? FAQ

- Turn-around time is between <u>3 AND 45 DAYS</u> from first sketch to finished piece if applicable.
- Rush-order commissions are not accepted.
- Certain circumstances can happen that may prolong the commission timeframe. It is of vital importance that you are patient with me.
- Impatience will not be tolerated; you may check back periodically if I do not update my queue status within five (5) business days. Doing so, as stated previously, will not expedite your wait time.

CAN I COMMISSION YOU?

• Yes! Commission request require that you be 18 or older.

- For regular commissions work in progress will be sent to you if applicable for any adjustments that need to be made.
- Minor edits for premade Your Character Here (YCH) Sketch Style commissions may be made after completion.
- Major edits after the inks are complete are subject to additional charge. Such as altered positions removed or added parts of a piece.
- Edits may not be made after piece completion after 24 hours have passed.
- I reserve the right to refuse any major edits that may be of inconvenience such as changing characters or changing character species.
- I reserve the right to deny any commission work request at my discretion.
- You are not allowed to make edits or alterations to any artworks without my expressed permission.



PAYMENT POLICY & REFUNDS AND CANCELLATIONS

- When invoices are created they are due within 24 hours of receiving them. An automatic reminder is sent to you after the 24 hour mark. After 48 hours has passed of non-payment you will be contacted and possibly have your commission cancelled.
- All prices will be in United States Dollar (USD), are final and non-negotiable. A tax of 6% is added to each commission.
- All sales are final!

UPLOAD POLICY, PRIVATIZATION AND DISTRIBUTION & ARTIST RIGHTS

- Commissions remaining private are subject to a charge no less than \$40 and up to quote.
 - Artworks are the de facto base for new potential clientele; pieces being withheld from the public view either for an extended period or until further notice are subject to this and are non-negotiable.
- The artist retains all rights to the images produced and may be used by the artist for promotional material, duplication and distribution or to sell merchandise; no derivatives can be made by the client for profit, distribution or duplication or to sell merchandise.
- Any and all watermarks on the image must remain.
- My works are protected with <u>CC BY-NC-ND 4.0 International</u>
- You may upload the artwork you received at your own discretion.
- I reserved the right to reuse, alter or derive previous works for future pieces for new clients at my discretion for premade pieces and commissioned pieces.
- The client may not edit or alter works unfinished or otherwise without the artist's permission.
- The client will not use works for the sale of NFTs or be used to generate/train AI models or be used for AI content of any kind for profit, non-profit, private or public use.
