Mortgage Relief Options for Homeowners Affected by Hurricanes Harvey or Irma

**Mortgage help:** Federally regulated Fannie Mae and Freddie Mac have come together to get the word out about mortgage relief options for those affected by natural disasters, including Hurricanes Harvey and Irma. Our goal is to make sure you have time to focus on your safety. Here is what you need to do to get help.

What help is available? If you are affected by the recent hurricanes, you are eligible to temporarily stop making your monthly mortgage payment for up to 12 months. At the end of this temporary payment break:

- You won't have late fees.
- You won't have delinquencies reported to the credit rating agencies.
- You won't have to catch up on all of your payments at once.
- You can work with your servicer to resume making a mortgage payment that is similar to what
  you paid before the disaster. Or if you need additional assistance, you can work with your
  servicer on options to keep your home.

Contact your mortgage servicer (the company where you send your monthly payments) as soon as possible to let them know about your current circumstances. The telephone number and mailing address of your mortgage servicer should be listed on your monthly mortgage statement. As Irma slowly dissipates, we are gathering information about the storm's impact across the Caribbean and U.S. To help you determine how to most effectively respond, the Center for Disaster Philanthropy team would like to share the following resources:

- First, in partnership with the <u>Southeastern Council on Foundations</u> and the <u>Council on Foundations</u>, we are hosting a "<u>Hurricane Irma: What Funders Should Know</u>" webinar, this Thursday, September 14 at 3pm ET/2pm CT. The panel for this webinar is one of our best yet and includes experts from <u>FEMA</u>, <u>UN OCHA</u>, the <u>Florida Philanthropic Network</u>, and the <u>Jessie Ball duPont Fund</u>.
- Second, in anticipation of Hurricane Irma's magnitude, the Center for Disaster Philanthropy
  launched the <u>CDP Hurricane Irma Recovery Fund</u>. We expect the long-term needs to be rebuilding
  homes, businesses, infrastructure, meeting the needs of young children, and supporting mental

- health needs. Geographically, the fund will focus on the entirety of the storm's impact area. Specific location and need-focus will be determined by the grant committee.
- Third, our disaster profiles for <u>Hurricane Harvey</u> and <u>Hurricane Irma</u> are being regularly updated to
  provide you information on NGO activity, funder responses, funds that have been launched, and
  storm background.

USHRN will co-host a <u>National Human Rights and Long-term Gulf recovery call on Wednesday, September 13, 2017 at 1:00pmEDT</u> to offer a detailed assessment from the ground in the Harvey zones that are not getting a lot of press attention.

In the meantime, I wanted to tell you about USHRN Response Efforts:

- Direct Response: USHRN will be collecting donations (drop offs in Slidell, LA and Atlanta, GA;) of cleaning supplies to take to Native American communities and independent African American churches in Southwest Louisiana. <a href="Support Needed: \$4,000 (space)">Supply donations</a> non-toxic, cleaning supplies; protective gear (gloves, boots, eye and face protection),
- Community Controlled Fund- Hurricane Harvey. USHRN will act fiscal agent for this <u>Gulf South Rising community controlled fund- Hurricane Harvey fund</u> and will facilitate 100% of all donations received, managed and distributed by the grassroots/frontline community members. The GSR initiative created a unique, effective and community-governed process to collect dollars intended for communities in crisis. The link will go live at <a href="www.gulfsouthrising.org">www.gulfsouthrising.org</a> on <a href="Friday 9/1/2017">Friday 9/1/2017</a>. <a href="Support">Support</a> Needed: \$5.000 (web tech/support): donations of any size.
- Disaster Volunteer Human Rights Training: USHRN will be hosting a series of human rights training for volunteers headed to support recovery in the Harvey zone. Advised by USHRN members that are survivors of hurricanes Katrina, Rita, Gustav and Ike, Gulf Coast leaders of Color will co-lead training that offers information and best practices for being of service and building power. The training will offer tools for volunteers to help protect human rights in climate disaster recovery. Volunteer crews will leave with a perspective that shifts their focus from charity to authentic alliance. Gulf Coast leaders will be connected with support for communities often left our or prioritized from recovery resources. Support Needed: \$60,000 (staff and space)
- Human Rights Community Clinics: US Center for Climate Law & Policy is USHRN's newest program
  built on the programming merger of the Gulf Coast Center for Law & Policy. We will be delivering
  community human rights clinics throughout south Texas and south Louisiana. Clinics will coordinate
  legal services volunteers to provide 1) collective healing sessions (rooted in sustainable, traditional
  practices); 2) legal support (with FEMA, Red Cross, evictions, heir's property and Immigration issues);
  and 3) political education sessions connecting human rights and climate change. These sessions will
  have childcare, translation, food and community information. Support Needed: \$40.000 (3-5 clinics)
- Climate & Human Rights Defenders Strategy Summit: USHRN will host Climate Leaders and Human Rights Defenders from December 6-10 in Atlanta (2017 national Advancing Human Rights convening) to provide space to healing and respite during our national gathering. Selected leaders will reflect on recent climate disaster events and the human rights violations that occur, then strategize on best steps toward building more sustainable communities in the midst of this new climate reality. Support Needed: \$42,500 (50 advocates/leaders).
