

## Privacy Policy

This privacy policy applies to the Glam genie app (hereby referred to as "Application") for mobile devices that was created by Mitesh Yadav (hereby referred to as "Service Provider") as a Free service. This service is intended for use "AS IS".

## Information Collection and Use

The Application collects information when you download and use it. This information may include:

- Your device's Internet Protocol address (e.g., IP address).
- The pages of the Application that you visit, the time and date of your visit, and the time spent on those pages.
- The operating system you use on your mobile device.

The Application does **not** gather precise information about the location of your mobile device.

The Service Provider may use the information you provide to contact you from time to time to provide you with important information, required notices, and marketing promotions.

For a better experience while using the Application, the Service Provider may require you to provide certain personally identifiable information, including but not limited to **mitesh.collab@gmail.com**. The information that the Service Provider requests will be retained by them and used as described in this privacy policy.

## Camera and Gallery Access

To provide clothing recommendations based on your uploaded images, the Application requires access to your device's **camera** and **gallery**. This access is used solely for the purpose of allowing you to upload photos for fashion recommendations.

**Please note that any photos or images uploaded via the Application are processed locally on your device and are not stored in our system or database.** The photos are used only for the purpose of generating recommendations and are not shared with any third parties.

## Third-Party Access

Only aggregated, anonymized data is periodically transmitted to external services to aid the Service Provider in improving the Application and their service. The Service Provider may share your information with third parties in the ways described in this privacy statement.

Please note that the Application utilizes third-party services that have their own privacy policies about handling data. Below are the links to the privacy policies of the third-party service providers used by the Application:

The Service Provider may disclose User Provided and Automatically Collected Information:

- With their trusted service providers who work on their behalf, do not have an independent use of the information we disclose to them, and have agreed to adhere to the rules set forth in this privacy statement.

You can stop all collection of information by the Application easily by uninstalling it. You may use the standard uninstall processes as available as part of your mobile device or via the mobile application marketplace or network.

## **Data Retention Policy**

The Service Provider will retain User Provided data for as long as you use the Application and for a reasonable time thereafter. The Service Provider does not use the Application to knowingly solicit data from or market to children under the age of 13.
