Introduction

Definition of Key Terms

Social Safety Nets (SSNs): systems deployed by governments and associations to improve the lives of vulnerable and poor families or individuals. (Worldbank, The State of Social Safety Nets)

Social Mobility: movement of individuals, families, households or other categories of people within or between different classes in the social stratification of a society. It is a change in social status relative to one's current social location within a given society. (OECD, Economic Policy Reforms 2010)

Background Information

History of SSNs

The term Social Safety Nets (SSNs) refers to a set of programs and measures that has no exact introduction point. It really depends on the point of view of historians but also on the region. A significant step in their implementation happened in the 1990s with work from the Bretton Woods institution. The SSNs were implemented as part of structural adjustment programs aimed at restructuring the economies of certain developing countries. And that's during that time that they really showed their importance. (Worldbank)

The United Nations, through its Sustainable Development Goals (SDGs), emphasises the importance of SSNs in achieving the goal of eradicating poverty. The SDGs encourage countries to develop and implement social protection systems and measures, including the establishment of minimum standards, or "floors", of social protection. The ultimate target is to achieve substantial coverage of the poor and vulnerable populations by 2030.

The COVID-19 pandemic has had a significant economic impact worldwide, leading many countries to enhance their existing SSNs or introduce temporary SSNs. These measures have aimed at reducing the negative effects of the lockdown and at providing support to individuals and families facing financial hardships because of this crisis.

Current SSNs in the World

There are multiple Social Safety Nets (SSNs) existing all around the world in various sectors, such as unemployment benefits, food assistance, healthcare programs, and housing support. More Economically Developed Countries (MEDCs) are the ones with the most advanced systems. The generosity inherent to the SSNs really depends on the country and its policy regarding the social well-being of its population.

For example, let's compare the healthcare systems in France and the United States of America. France offers a universal healthcare system that provides coverage for all its citizens, regardless of their income or employment status. This means that everyone has access to healthcare

services without having to worry about the cost. The French system is less focused on cost and more on providing comprehensive coverage.

On the other hand, the United States has a more complex healthcare system. It relies heavily on private health insurance, with individuals and employers purchasing insurance plans to cover their healthcare expenses. This means that the cost of healthcare in the US can be quite high, especially for those who are uninsured or underinsured. The US system is more cost-focused, with individuals having to navigate various insurance plans and providers to receive the care they need.

However, it is important to note that this is a simplified explanation of those systems, each of which is much more complex and includes nuances that the brief comparison above cannot capture.

Differences Between SSNs

As previously mentioned, the amount of money allocated to SSNs varies from country to country. According to the Organisation for Economic Co-operation and Development (OECD), MEDCs typically spend around 2.7% of their Gross Domestic Product (GDP) on these systems. In contrast, Less Economically Developed Countries (LEDCs) tend to allocate an average of 1.5% of their GDP to their systems.

It is important to note that there are also disparities among different regions. European and Central Asian countries stand out as the highest spenders on SSNs, dedicating a larger portion of their GDP compared to countries in Sub-Saharan Africa, Latin America and the Caribbean, East Asia and the Pacific, the Middle East and North Africa, and South Asia.

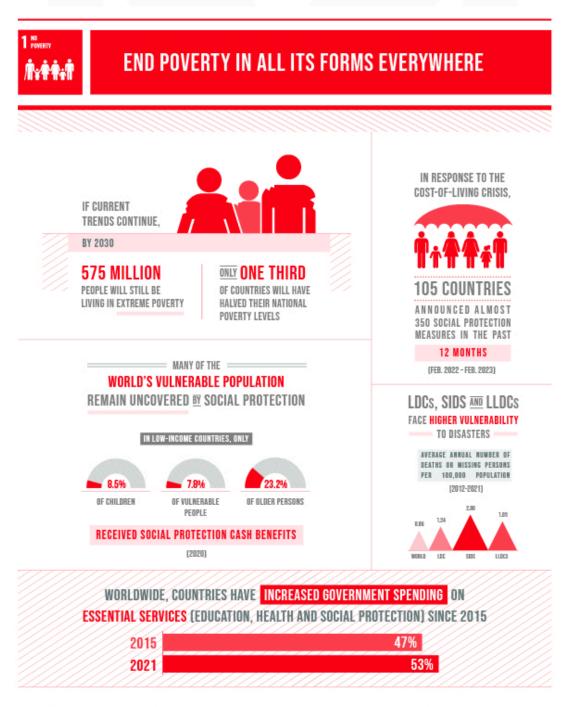
The Link Between SSNs and Equality and Social Mobility
