#### **COURSE RATIONALE**

The objective of this course is to provide students with a detailed picture of how successful companies manage human resources in order to compete effectively in a dynamic and global environment.

## **Review Questions**

A series of review questions will be assigned for each chapter. You must complete the assigned review questions by the due date and submit them through Blackboard. Please write out the question and then your answer. We will also discuss the review questions during our virtual class meetings.

## **Learning Activities**

A learning activity related to subject matter videos and articles will be assigned for most chapters. You must complete the learning activity and related questions by the due date and submit them through Blackboard. Please write out the question and then your answer. We will also discuss the learning activity during our virtual class meetings.

## **Discussion Boards**

A discussion board topic and related questions will be assigned for most chapters. In most cases, students must submit one (1) thread and respond to at least two (2) others in sentence format to be eligible for full credit. The assignment must be completed by the due date and submitted through Blackboard. We will also review the discussion board topics during our classroom meetings.

## **Exams/Missed Exam Policy**

There will be two (2) course exams. Each exam will include multiple choice questions and may include essay questions. All exams will be administered online through Blackboard. Students will be allowed use their notes and the book during the exam. Each exam will be timed. Information covered in reading assignments as well as class discussions, guest lectures and presentations will be included on the exams. Passing the exams, and ultimately the course, will be a measurement of your ability to apply theories and concepts learned during the semester, rather than your ability to simply memorize information. All students must take <u>both</u> exams in order to pass the course.

## **Attendance/Class Participation**

Attendance is mandatory for all virtual class meetings. Professional courtesy also requires that you arrive on time and that you are prepared. If you are absent from the virtual class meetings for <u>any reason</u>, your attendance points will be affected in the following ways:

If you are more than 30 minutes late for class without having made prior arrangements with the instructor, your tardiness will be counted as an absence. It is your responsibility to obtain lecture notes and other information covered in class from a fellow student in the event of your absence.

\*Students who are absent for three (3) synchronous/virtual or in-person class meetings for <u>any reason</u> will receive a 125- point <u>penalty</u> deduction. Any special circumstances should be discussed with the instructor. Students who are absent for four (4) or more synchronous/virtual or in-person class meetings for <u>any</u> reason will <u>not</u> pass the course.

In the event the college or campus closes due to unforeseen circumstances (for example, severe weather or other emergency), the student is responsible for communicating with their professor during the closure and completing any assignments or other activities designated by their professor as a result of class sessions being missed.

#### Withdrawal Policy

It is the responsibility of each student to ensure that his or her name is removed from the rolls should they decide to withdraw from the class. The instructor does, however, reserve the right to drop a student should he or she feel it is necessary. ## **Incompletes**

An incomplete (grade of "I") will only be given for extenuating circumstances. What constitutes "extenuating circumstances" is left to the instructor's discretion. If a grade of I is given, the remaining course work must be completed by a date set by the student and professor. This date may not be later than two weeks prior to the end of the following semester. A grade of I also requires completion and submission of the <u>Incomplete Grade form</u>, to be signed by the faculty member (and student if possible) and submitted to the department chair.

Students may request an Incomplete from their faculty member if they believe circumstances warrant. The faculty member will determine whether the Incomplete is appropriate to award or not. The following processes must be followed when awarding a student an I grade.

- Prior to the end of the semester in which the "I" is to be awarded, the student must meet
  with the instructor to determine the assignments and exams that must be completed prior
  to the deadline date. This meeting can occur virtually or in person. The instructor should
  complete the Report of Incomplete Grade form.
- 2. The faculty member will complete the form, including all requirements to complete the course and the due date, sign (by typing in name) and then email it to the student. The student will then complete his/her section, sign (by typing in name), and return the completed form to the faculty member to complete the agreement. A copy of the fully completed form can then be emailed by the faculty member to the student and the

department chair for each grade of Incomplete that the faculty member submits at the end of the semester.

- 3. The student must complete all remaining work by the date specified on the form above. This date is determined by the instructor in collaboration with the student, but it may not be later than the final withdrawal deadline in the subsequent long semester.
- 4. Students will retain access to the course Blackboard page through the subsequent semester in order to submit work and complete the course. Students will be able to log on to Blackboard and have access to the course section materials, assignments, and grades from the course and semester in which the Incomplete was awarded.
- 5. When the student completes the required work by the Incomplete deadline, the instructor will submit an electronic Grade Change Form to change the student's performance grade from an "I" to the earned grade of A, B, C, D, or F.

If an Incomplete is not resolved by the deadline, the grade automatically converts to an "F." Approval to carry an Incomplete for longer than the following semester or session deadline is not frequently granted.

## **Use of Generative Artificial Intelligence**

For the benefit of both faculty and students, it is critical for each instructor to specify how and to what extent (if any) generative artificial intelligence (GAI) is incorporated into their course. To assist with this, a working group of interdisciplinary faculty at ACC has developed a template, guidelines, and examples: these are available on the <u>Artificial Intelligence Draft Policies website</u>. Examples include options ranging from the forbidding of any GAI use to moderate incorporation into the curriculum to significant integration of GAI into the course curriculum. The statement should include:

- 1. <u>Introduction</u> Introduce your policy on GAI use in the course
- 2. <u>Rationale</u> State why GAI is prohibited/permitted/required to be used in the course
- 3. <u>Definition of GAI</u> Define what GAI is in the context of the course
- 4. <u>Resources</u> In courses that permit or require GAI, provide resources that guide students on how to properly use GAI in the course
- 5. <u>Assessment</u> In courses that permit or require GAI, clarify if and how its use will be assessed in the completion of activities
- 6. <u>Penalties</u> Clearly state the consequences of violating the GAI policy
- 7. <u>Exceptions</u> Explain any conditions under which there may be an exception to the GAI policy in the course
- 8. <u>Usage Permissions</u> –

- a. Prohibited Clearly state what GAI activities are not allowed
- b. Permitted Clearly state what GAI activities are allowed
- c. Required Clearly state what GAI activities are required

- Student Accessibility Services (SAS) Testing: All approved SAS testing
- Assessments Tests: Institutionally approved assessment tests (e.g., TSIA or TABE)
- Placement Tests: Placement tests (e.g., ALEKS)
- Make-Up Exams (for students who missed the original test): Make-up testing is available
  for all lecture courses but will be limited to no more than 25% of students enrolled in
  each section for each of four tests
- Programs incorporating industry certification exams: Such programs (e.g., Microsoft, Adobe, etc.) may utilize the ACC Business Assessment Center for the industry certification exams (BACT) at HLC or RRC

## **Student Accessibility Services**

Austin Community College (ACC) is committed to providing a supportive, accessible, and inclusive learning environment for all students. Each campus offers support services for students with documented disabilities.
