I have received a chromebook to support my learning and achievement. By accepting the possession of the chromebook, I agree to the following, including the caregiver and student expectations. I understand that it is to be used for schoolwork only. I shall not sell, lease or otherwise grant anyone rights to the chromebook. I shall adhere to the School's rules and regulations governing the use of the chromebook and comply with all applicable copyright and other regulations regarding the device.

I understand that I am responsible for loss of or damage to the chromebook, charger, Yondr pouch and or calculator. The School may request the chromebook be returned at any time. Upon request by the School or termination of the Agreement, I must return the chromebook to the School, in the same condition as on the Agreement beginning date, reasonable wear and tear excepted. Some common sense actions you must take to protect the Laptop, software and confidential data that may be on the chromebook include, but are not limited to the following:

- Do not leave unattended in a car, an unlocked home, or in a public place (i.e. coffee shop)
- Keep information password-protected, log off when you are away from your computer
- Protect from liquids or dampness
- Protect from extreme temperatures (i.e. do not leave in trunk of car for long periods of time)

I agree to accept the chromebook "as is." In no event shall the School be liable to me for my use of the chromebook.

I agree to return my chromebook at the end of every school year. Over the summer the chromebooks will be inspected and updated to ensure they will be in good working order for the next school year. Students will in most cases receive their same chromebook back after the summer break.

I agree to the terms of this agreement. I understand that in the event of theft, misuse or carelessness, there is no provision for replacement. I understand that if loss or damage occurs while the chromebook is anywhere outside/inside of the school building, I am responsible for any damage, and in case of theft, for filing an official police report and informing my school immediately.

Caregiver Agreement

CAREGIVER

Great River School requires a yearly, refundable \$45 security deposit for each device loaned. This cost covers the expense of a charger, case, potential repairs, Google licensing fee, Yondr pouches, and calculators.

Before the technology is assigned to a student, the caregiver must assume financial responsibility for the equipment by signing this agreement. Wear and tear on the chromebooks is expected, and occasionally chromebooks may require repairs through no fault of the student. Whether a repair needed is a result of negligence or expected wear is at the discretion of the Program Director in consultation with the Technology Coordinator.

I will personally guarantee reimbursement of the replacement value of the chromebook to the School or I will make arrangements with my school to work to an agreed upon number if the equipment is lost or damaged.

Keyboard/Trackpad Repair	\$50
Power Adaptor, Charger Port and/ or Audio Jack Replacement	\$30 each
Calculator Replacement	\$90
Yondr Replacement fee	\$30
