Permissions and use

- This app does require a permission to access the Microphone (RECORD AUDIO) in order to detect whistle sound. App does not send the recording to us or anyone.
- This app requires a permission for (POST NOTIFICATIONS) in order for foreground service to show notification.
- This app requires a permission for (PHONE CALLS) in order to pause whistle detection while on call.

- Other permissions include (WAKE_LOCK , FOREGROUND_SERVICE, RECEIVE_BOOT_COMPLETED, VIBRATE) in order to run properly.

Log Data

We want to inform you that whenever you use our Service, in the case of an error in the app we collect data and information (through third party products) on your phone called Log Data. This Log Data may include information such as your device Internet Protocol (“IP”) address, device name, operating system version, the configuration of the app when utilizing our Service, the time and date of your use of the Service, and other statistics.
