#### What personal information do we process?

When you visit, use, or navigate our Services, we may process personal information depending on how you interact with us and the Services, the choices you make, and the products and features you use.

Learn more about the personal information you disclose to us. Any and all information collected however is associated only with a randomly generated User ID, which cannot be linked back to your personal identity.

#### Do we process any sensitive personal information?

We do not process sensitive personal information.

#### Do we receive any information from third parties?

We may receive information from public databases, marketing partners, social media platforms, and other outside sources. Any such information would be tied to a randomly generated User ID, which cannot be linked back to your personal identity.

#### How do we process your information?

We process your information to provide, improve, and administer our Services, communicate with you, for security and fraud prevention, and to comply with law. We may also process your information for other purposes with your consent. We process your information only when we have a valid legal reason to do so.

#### What are your rights?

Depending on where you are located geographically, the applicable privacy law may mean you have certain rights regarding your personal information.

#### How do you exercise your rights?

The easiest way to exercise your rights is by going to the profile page of our app, settings, and deleting your account. Doing this data will completely, and permanently, delete all cloud-stored data, such that you have no information stored with us.

### **Personal information you disclose to us**

Any information collected from us is only ever tied to an anonymous User ID. That said, the contents of your tasks are stored in a cloud database. Therefore, we strongly urge you never to include sensitive and/or personal information in your tasks. We only collect information that you voluntarily provide to us when you register on the Services, when you participate in activities on the Services, or otherwise when you contact us.

### **1. HOW DO WE PROCESS YOUR INFORMATION?**

We process your information to provide, improve, and administer our Services, communicate with you, for security and fraud prevention, and to comply with law. We may also process your information for other purposes with your consent.

### **2. WHEN AND WITH WHOM DO WE SHARE YOUR PERSONAL INFORMATION?**

Any shared information would be collected by third party services regarding subscriptions, app store analytics, and/or cloud services analytics. These are largely outside our control - we ensure that all information is always, at most, tied only to an anonymous User ID. Your user name in the app is only ever stored locally on your device, and can therefore never be accessed by us.

### **3. HOW DO WE HANDLE YOUR SOCIAL LOGINS?**

Our Services offer you the ability to register and log in using your third-party social media account details. Where you choose to do this, we will receive certain profile information about you from your account. Specifically, log in for Fuji: A new focus. uses 'Sign in With Apple'. Please note that we do not control, and are not responsible for, other uses of your personal information by this sign-in method. ### **4. IS YOUR INFORMATION TRANSFERRED INTERNATIONALLY?**

We may transfer, store, and process your information in countries other than your own. Our servers are located in Canada. However, we will take all necessary measures to protect your personal information in accordance with this privacy notice and applicable law.
