

Pizza Quiz Sweepstakes

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. SWEEPSTAKES IS OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO U.S. LAW. Sweepstakes Period: The Pizza Quiz Sweepstakes (“Sweepstakes”) begins at 12:00:01 AM Eastern Time (“ET”) on October 8, 2025, and ends at 11:59:59 PM ET on October 31, 2025 (the "Sweepstakes Period"). There will be a total of four (4) weekly entry periods (each a “Weekly Entry Period”) during the Sweepstakes Period. The Weekly Entry Periods are outlined in the chart below. For purposes of this Sweepstakes, each Weekly Entry Period during the Sweepstakes Period begins on Monday at 12:00:01 AM ET and ends the following Sunday at 11:59:59 PM ET, except for the first Weekly Entry Period which will begin at 3:00:01 PM ET on Wednesday October 8, 2025, and the final fourth Weekly Entry Period, which begins on Monday October 27, 2025, at 12:00:01 AM ET ends at 11:59:59 PM ET on Friday, October 31, 2025.

Eligibility: The Sweepstakes is open to legal residents of the fifty (50) United States or the District of Columbia, at least 18 years of age (or the age of majority in their state of residence, whichever is older) at the time of entry. Sponsor will not be responsible for lost, late, misdirected, delayed, incomplete Entries, or Entries submitted in a manner that is not expressly provided herein, and all such Entries shall be deemed void and ineligible for inclusion in the Sweepstakes.
