- 1) **Colour coded: Blue**-in-colour font means 'new updated information'.
- 2) **Selection and appointment process:** CAB has the necessary selection and appointment process for Medical Device Technical Expert, taking into account the competencies required to achieve audit objectives and impartiality requirements.
- 3) **Appointed by CAB to support specific technology areas:** Medical Device Technical Experts are appointed by CAB based on their qualifications and experience in specific technology areas related to medical devices through the provision of technical assistance required to carry out compliance assessments.
- 4) **Role during the audit activity:** The Medical Device Technical Expert's role during the audit activity needs to be agreed by the CAB and the client before implementation and the Medical Device Technical Expert does not act as a CAB Auditor in the audit team, but provides the necessary technical advice.
- 5) **Accompanied by CAB Auditors:** Medical Device Technical Experts should be accompanied by CAB Auditors during audit activities to ensure that all technical aspects are considered during the compliance assessment.
- 6) **Provide advice to the CAB audit team:** Medical Device Technical Experts provide advice to the CAB audit team in the preparation, planning, or audit to ensure compliance with applicable standards and guidelines.
- 7) **Provide technical support to CAB Auditors or CAB Technical Personnel:** Medical Device Technical Experts are responsible for providing guidance, support and advice based on their technical knowledge to the audit team or technical staff in the process of testing and inspecting medical devices.
- 8) **Medical device testing of medical gas systems:** This involves testing the effectiveness, safety, and efficiency of medical devices that use medical gas systems to ensure that they function as expected and comply with applicable standards.
- 9) **Provide research and development input:** Medical Device Technical Experts are involved in research and development to improve the efficiency and safety of medical devices through the contribution of ideas and insights to advance medical technology.
