6. President's 2021 Report

The President presented his report.

The club hosted several well attended social events, Oli and Desiree were thanked for their contributions.

Unfortunately, disciplinary practices have been enforced, as a result of one incident at the club. The president also reminded the club of the zero-tolerance approach to misconduct, and that the member protection officers are there for club members.

The club made a surplus of \$9,000. This was because there were no equipment orders carried out. The largest expenses were facility hire and a substantial number of beginner course attendees that received refunds.

The president thanked the committee and the club, and expressed his gratitude for everyone who made his three years as president enjoyable. He gave his best wishes to the next president.
