OUAC Important upcoming dates

- 1. Guidance Spring Dialogues (Virtual) April 24, 9:30 11:30 am
- 2. April Grades Deadline April 24/May 1 April 24
 - Deadline for Ontario high schools to report all midterm or final grades available for 4U/M courses and interim grades for full-year courses to the OUAC. The OUAC will send the grades we receive before the deadline to Ontario universities when they are received.

May 1

- Target date for Ontario universities to receive all midterm or final grades available for 4U/M courses and interim grades for full-year courses from the OUAC. The OUAC will send the grades we receive before the deadline to Ontario universities when they are received.
- Grace period built in to accommodate schools experiencing reporting issues.

3. University Response Deadline - May 29

The latest date all high school applicants who submitted their application by the January application deadline can expect a response from an Ontario university. This includes an offer of admission, a refusal or a deferral, once additional information is received.

4. Applicant Response Deadline – June 2

The earliest date an Ontario high school student may be required to respond to an Ontario university offer of admission and give a financial commitment (e.g., registration deposit, residence deposit, etc.). All other admission-related elements, including scholarships, other forms of student assistance or financial incentives, and offers of residence, are considered part of the offer of admission. Therefore, a student may accept these other offers before June 2, 2025, but Ontario universities will not compel a student in any way to make a decision before this date.

Discover Year - Request for Flyers

- Program began with student inquiries at Ottawa U and employers
- Private career college earning a certificate in career and leadership skills.
- Coaching model is used and can be matched with a coach.
- Locations Toronto, Ottawa, and remote.
- 75% come directly from high school.
- Age range 17-22 with average is 18.5
- 1:6 ratio with facilitator to student
- RESP can be used
- Students have tuition, however work experience is paid and they often have additional funds by the end (approx. \$6000)
- Support to find housing in September stay in a hostel with the group (former jail, kind of fun, rooms are blocked for them). Hostel fee is extra and amounts to about \$400 for the two weeks.

- Financial Literacy Graduation Requirement
 - May 2024 announcement , beginning in September 2025, students will be required to successfully complete a financial literacy graduation requirement as part of the Grade 10 mathematics course to ensure that all Ontario graduates possess essential financial skills and knowledge.
 - TVO, liaise with subject matter experts. TVO will be the primary point of contact for technical questions regarding development and administration.
