



Racer / Entrant / Participant Waiver

All participants acknowledge and accept the following terms and conditions of participation in the registered event.

I, the named participant (registrant), and on behalf of anyone I register through my online account on their behalf (referred to as 'my others'), in consideration of and as a condition of acceptance of my / their entry in the Banana Island Aquathlon event for myself, my others, my heirs, executors, and administrators hereby waive any claim, right of claim, cause of any action which they or I might have arising out of loss of my life or injury, damage or loss of any description whatsoever which I or my others may suffer or sustain in the course or consequent upon me or my others' entry or participation in the event.

I know that participating in such an event is a potentially hazardous activity. I and my others assume all risks associated with participating in this event, including but not limited to falls, contact with other participants, the effects of weather, traffic, and the conditions of the road/sea/trail or other courses, all such risks being known and appreciated by me and my others.

This waiver, release, and discharge shall be and operate separately in favor of all persons, corporations, clubs, sponsors, and bodies involved with or otherwise engaged in promoting or staging the event and the servants, agents, representatives, and officers of any of them.

I and my others attest that I am / we are physically fit and medically able to complete part or the entirety of the course without jeopardizing my / our health or life and consent to receive medical treatment that may be advisable in the event of illness or injuries suffered by me / my others during this event.

I and my others give free permission for the unrestricted use of our names, voices, or pictures in any broadcast, telecast, advertising promotion, or other accounts of this event.

I and my others understand that no liability of any kind will attach to any person, corporation, or body involved in connection with the event in case of cancellation or postponement.

I and my others satisfy all entry requirements as set out.

I and my others agree to abide by the conditions of the event as stated in the declaration above and upon literature and other material distributed in connection with the event. By registering myself and others for this event, I fully accept these Terms & Conditions, which are subject to change without prior notice.

The event organizer reserves the right to reject any entry and further reserves the right to change the details of the above-referenced event without prior notice.

I confirm I have medical insurance/coverage to participate in a race and am covered for participation whilst in Qatar. I understand any medical treatment in Qatar may incur a charge, and I, the participant, have the necessary insurance/coverage for this.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus ("COVID-19") has been declared a worldwide pandemic by the World Health Organization. COVID-19 is highly contagious and is believed to spread mainly from person-to-person contact. As a result, the Ministry of Public Health in the State of Qatar recommends social distancing. It has legislative guidelines regarding the congregation of people, wearing of masks, and presentation of a green code on the Ehteraz Application. The Organizers have put preventative measures in place to reduce the spread of COVID-19; however, all participants, personnel, and attendees acknowledge their understanding the event, staff, contractors, volunteers, partners, sponsors, and any associated third parties involved cannot guarantee that any individual or individuals will not become infected with COVID19 in conjunction with the event.
