Arthur Academy is taking steps to ensure safe drinking water by testing all faucets used for drinking water and food preparation

Arthur Academy will comprehensively test for lead in all water taps used for drinking water and food preparation in every school and building.

Where any elevated lead levels are found, the school will take steps to address the cause and provide a safe environment for students and staff. The school will:

- Immediately stop the water from being consumed and ensure a source of safe drinking water is available.
- Identify and eliminate the source of the lead.
- Retest the water to ensure it is safe for students and staff.
- Notify parents, students and staff of the results and actions taken.

Testing process

Arthur Academy has contracted with an independent professional environmental service, TRC Companies, to do comprehensive testing for lead in all water faucets for drinking and food preparation, following the Environmental Protection Agency's (EPA) recommended protocols for sampling water in schools. The EPA recommends taking action to reduce lead at any water outlet that has a lead level above 15 parts per billion (ppb) using these sampling protocols.

Where to learn more

Lead in water and other sources is a concern because high lead levels can contribute to serious negative health effects, especially for pregnant women, infants, and young children under 6 years old. Lead in drinking water is rarely the sole cause of lead poisoning, but it can increase a person's total lead exposure.
