The Zelgor Privacy Policy is intended to display our transparency under "GDPR", known as the "General Data Protection Regulation", along with "CCPA", known as the "California Consumer Protection Act.

HOW INFORMATION GETS COLLECT

Information and data are generally collected, but not limited to, the following three (3) ways:

1. Information voluntarily provided to us by, but not limited to, becoming a game tester, creating an account, making purchases, and/or signing up for our email and productional updates.
2. Information automatically collected from your use of Zelgors services via cookies, our game(s), and other software(s) and platform(s) integrated within our Zelgor services.

ZELGOR’S CHILDREN AND MINOR POLICY

Zelgor’s services are intended to be deemed appropriate for the general audiences and are not intended nor directed to children, children typically considered to be under thirteen (13), view [here](#) for a full defined list of the age of children throughout the world. Zelgor Inc. does not intentionally collect personal information from children without seeking any required parental approval in accordance with applicable legal and regulatory obligations, such as the U.S. Children’s Online Privacy Protection Act (“COPPA”).
