

→ TERMS OF SERVICE **→**

♦ I. GENERAL ◆

- I reserve the right to decline a commission for any reason, with or without explanation.
- All payments I receive are for digital goods. Purchases cannot and will not be shipped physically.
- All clients must be 18 or older, regardless of commission content.
 - However, exceptions to this rule can be made if you are 16+ and paying for yourself.
- Clients are fully responsible for saving and storing finished artwork. If any artwork is lost, clients may contact me for help, but recovery is not guaranteed.
- None of my artwork is to be used for hateful or oppressive content. Including, but not limited to: racism, homophobia, transphobia, ableism, etc.
- None of my artwork is to be used for any cryptocurrency or NFT-related content.
 Including, but not limited to: direct usage as an NFT, advertisement, etc.
- None of my artwork is to be used for any form of Al generation. Including, but not limited to: use in any learning models, use with Al chat bots, etc.

♦ II. RIGHTS ♦

- I retain all rights to my artwork. I also may use any artwork for any non-commercial use, unless told not to during the commission process.
 - This includes posting the artwork to social media, using it as an example, using it to create personal work, etc.
- Clients may use their artwork for any non-commercial use by default, but must credit me. Clients cannot claim my work as their own.
- Clients do not receive commercial rights to any artwork they commission, and cannot use it for profit.
 - If a client would like to purchase commercial rights, they can contact me at any time to discuss.

♦ III. COMMISSIONING ◆

- Payment is taken upfront and in full before work on a commission begins.
- Clients can only commission artwork that includes characters they own themselves, or are allowed to use by the character's owner.
 - Characters from publicized media-- ie. characters from TV shows, anime, comics, etc.-- are also allowed.
- Clients must alert me of any deadlines upfront when commissioning. Otherwise, I will not attempt to fulfill them.
- Large changes to a commission may incur extra fees, but are not required for the piece to be finished without the changes. Be thorough when commissioning to avoid this.
 - Small changes or mistakes on my end will not incur any extra fees.
 - Artistic freedom is allowed for any part of a commission, but large changes may incur extra fees or be outright denied.

→ IV. PROCESS →

- Commissions can be finished in a few days to a few months. However, I make an
 effort to complete things in a reasonable and timely manner.
 - Do not message me about the status of your commission unless it has been at least a month.
- Clients will be sent a sketch for confirmation and discussion, and once confirmed,
 I will continue with the commission until it is completed.
- Clients can request changes to their commission at any point, but any fees incurred will vary in price based on the commission's progress.

♦ V. CANCELLATIONS AND REFUNDS ♦

- I reserve the right to cancel a commission at any point in the commission process for any reason, with or without explanation.
 - If I choose to cancel a commission, the client will receive a full refund, regardless of the commission's progress.
- Clients can discuss refunds at any point, and the refund amount will be based on the commission's progress.
 - Full refunds are only available if I have not completed the sketch yet, or in the case of serious emergencies.
- Clients who file chargebacks or otherwise attempt to receive a refund by force, regardless of the commission's progress, will be permanently blacklisted, and receive public warnings on both my social medias and on Artist's Beware.

♦ VI. DESIGN TERMS ♦

- For clarity, "design" refers to any character directly designed by me. This includes adoptables and any other designs I have solely designed.
 - In the case of redesigns or other design assistance, the original design's rules apply over mine.
- Once a client purchases a design by me, it is theirs. Clients have both non-commercial and commercial rights for the design itself, and designs will never be revoked unless a client has heavily broken my Terms of Service.
 - Clients do not, however, have commercial rights to my artwork specifically.
 If a client would like to purchase commercial rights, they can contact me at any time to discuss.
- Designs can be resold, traded, and/or gifted, regardless of how they were obtained.
 - Designs can also be resold for any price.
- Clients cannot claim my designs as their own.
