COMMITTEE CHARTER
2025-2027

Purpose

The purpose of the District 115 Board Policy Committee is to:

- Review and update (as needed) existing Board policies to ensure compliance with Illinois State law, and alignment to other District 115 Board and Administration policies and practices;
- Provide an effective forum for vetting, proposing, and discussing suggested/recommended changes to existing Board policies as well as suggested/recommended new Board policies;
- Provide feedback, insight, and direction to the District 115 Board as a whole regarding changes to existing policies and/or suggested new policies.

Like all Board Committees, the Policy Committee does not have the authority to approve or change Board policy. Only the District 115 School Board as a whole can approve changes/additions to Board Policy.

Membership

The Policy Committee membership consists of three (3) District 115 Board members, each appointed by the Board President. However, invitations are permanently extended to other Board members and key members of the District 115 Administration, such as:

- District 115 Superintendent
- Members of the District 115 Superintendent's cabinet
- LFHS Principal and/or LFHS Administrators
- Any other Administrator who may be affected by or have input into any suggested/recommended changes or additions to Board Policy.

Committee Activities/Areas of Focus

Specific activities of the Policy Committee may include (but are not limited to):

- Review of PRESS (Policy Reference Education Subscription Service) items and other recommended or statutory policies that come to the District through IASB (Illinois Association of School Boards) or other external agencies;
- Review of Policy issues raised by Board members, administrators, or others;
- Review of the entire Board Policy Manual.
