

**Resolution 2.41**: Request of Full Disclosure of the Potential Wesleyan Hengdian Campus **Introduced**: October 6, 2019

<u>Surprised</u> by the *Argus* article published on September 24th, 2019, detailing the University's consideration of establishing a joint-venture campus with Hengdian Corporation in the People's Republic of China<sup>1</sup>;

<u>Observing</u> that President Michael Roth and his cabinet did not intend to release any information about the potential Wesleyan Hengdian campus had the Wesleyan Argus not been informed about the plan;

<u>Calling</u> upon the University and the administration to be transparent with the community about projects with significant impact upon the campus community;

<u>Recognizing</u> the importance of involvement from students, alumni, faculty, and staff on proposals and projects put forth by the administration;

<u>Listening</u> to concerns among the entire Wesleyan community, including students, faculty, staff, and alumni, over the potential for the creation of this new campus;

<u>Acknowledging</u> President Michael Roth's upcoming trip to China, which will include visiting Hengdian Corporation;

<u>Understanding</u> that this matter remains complicated and ongoing, and as representatives of the student body, the Wesleyan Student Assembly has a responsibility to represent the interests of the Wesleyan student community;

The Wesleyan Student Assembly (WSA),

- 1. <u>Authorizes</u> the internal election of two WSA senators as student observers of the Wesleyan-Hengdian campus project by a majority of the General Assembly (GA).
  - a. <u>Requests</u> that the administration invite these two student observers to all private deliberations held within the administration concerning the project, including cabinet, faculty, or otherwise.

- <u>Requests</u> that the administration release all documents and digital files involving or concerning the development of the proposed Hengdian campus to the WSA to ensure full transparency,
- 3. <u>Requests</u> that the administration keep transparency in mind with regards to other projects and proposals that may impact any and all members of the greater Wesleyan community,
- 4. <u>Encourages</u> the University to continue hosting events such as the upcoming town hall on October 30th to update the campus on the progress of the project.

a. <u>Understands</u>, however, that students cannot ask informed questions about the project at such town halls without the fulfillment of the requests laid out above for further disclosure of information,

- 5. <u>Calls</u> for a WSA-hosted town hall to provide a forum for students to express their thoughts about the campus in Hengdian,
  - a. <u>Subsequently calls</u> for the creation of an anonymous Google form that will be sent out to the student body to allow feedback from students who would otherwise avoid publicly expressing their opinion out of concern for their safety,
- 6. <u>Trusts</u> that the administration will respond to each of the requests laid out in clauses 1a, 2, and 3 by Wednesday, October 16th, 2019,
- 7. <u>Remains</u> actively seized of the matter.
