*Therefore, be it enacted by the Student Senate of the University of North Carolina at Charlotte, as follows:*

***ARTICLE VI. ORGANIZATIONAL & COMMITTEE ACCOUNTABILITY & RESPONSIBILITY***

**SECTION 2. Grievances & Appeals**

**§6-2.3. Filing a Grievance.**

- (a) A student who believes that he or she was denied membership or participation in a student organization because of his or her age, race, color, national origin, disability, religious status or historic religious affiliation, veteran status, sexual orientation, or, unless exempt under Title IX, gender; may appeal such action in accordance with the Student Grievance Procedure that is ~~listed in Policy Statement #75, Student Appeals and Grievances,~~ found online at [legal.charlotte.edu](http://legal.charlotte.edu)
- (b) Any student or student organization who believes a student organization is not in compliance with the Act for Registration may file a grievance with the SGA Judicial Branch.
