No more than 4 members of staff in the staffroom at any one time. Teachers and Teaching Assistants will have staggered lunch times. Foundation Phase staff have their own staffroom and Key Stage 2 have a separate staffroom. When in the staffroom, all staff need to ensure they maintain 2 metre distance from each other.

Staff to maintain, so far as possible, 2m distance from pupils. It is acknowledged that this will not always be possible, particularly with younger children.

Staff to ensure that specific interactions which break social distancing with children occur as briefly and infrequently as possible.

Activities to be planned so as to discourage close or regular contact between individuals, staff and pupils, or the sharing of resources.

Any shared resources to be cleaned between users including: computer keyboards/mouse devices/PE equipment.

Children to be discouraged from engaging in games or interactions that require prolonged physical proximity or contact.

Windows and doors (if safe) to be opened for ventilation

Co2 monitors installed in every classroom and staff informed of procedure to follow in response to these

Learning outdoors will be maximised by all classes.

	Symptoms Children and young people with mild symptoms can continue to attend school. Mild symptoms include a runny nose, sore throat, or slight cough, in children who are otherwise well. Children and young people who are unwell and have a high temperature should stay at home. They should avoid contact with other people where they can. They can go back to their setting when they no longer have a high temperature and are well enough to attend.		
	If a child or member of staff tests positive		

Many people with COVID-19 will no longer be infectious after 5 days. You should therefore avoid contact with other people for at least 5 days after the day you took your test, or from the day your symptoms started (whichever was earlier).

Pregnant Staff

Individual risk assessment will be conducted with CP as soon as member of staff notifies of pregnancy.

Risk assessments will be undertaken again at 26 weeks+. The pregnant member of staff and the employer must be happy with the outcome.

Ventilation

Classrooms are adequately ventilated but must be maintained with not being too cold.

We understand that:

- Partially opening windows and doors can still provide adequate ventilation.
- Open higher-level windows to create fewer draughts.
- If the area is cold, relax dress codes so people can wear extra layers and warmer clothing.
- Set the heating to maintain a comfortable temperature even when windows and doors are partially open.
- Consider providing additional sources of heating if required. Only use fan convector heaters if the area is well ventilated.
- Regularly airing the space in rooms by opening windows and doors helps to reduce the risk from viruses in the air
