
Memorandum of Understanding

1. This Memorandum of Understanding (MoU) recognises and affirms that
 - a. the PROMETHEUS Network, consisting of all the project partners and associated partners as displayed in www.hei-prometheus.eu, and hereby represented by the PROMETHEUS Project Coordinator and the PROMETHEUS Partner, and
 - b. which becomes an Associated Partner of the PROMETHEUS Network, (together, the Parties), desire to develop a cooperative arrangement, whereby the Parties may participate in collaborative teaching, training, mentoring, research, and other entrepreneurship support activities that further enhance the relationship between the Parties and their mutual benefits.
2. The Parties will pursue **opportunities for cooperation**, which may include:
 - a. Students internships, from an action under the European Institute of Innovation and Technology
 - b. Higher Education Innovative Universities or other relevant institutions towards companies of the PROMETHEUS Network
 - c. Mentoring, sourcing of financing and other entrepreneurship support activities from the PROMETHEUS Network towards participating startups / scaleups
 - d. Visits of academic staff among universities or relevant institutions of the PROMETHEUS network for the purpose of participating in teaching, training, research or other agreed activities
 - e. Co-supervision of PhD students among universities or relevant institutions of the PROMETHEUS network
 - f. Student mobility (with activities to be addressed by way of a separate later student exchange agreement or joint PhD agreement, as appropriate)
 - g. Common research and development activities
 - h. Exchange of documentation, research materials, publications or other information
 - i. Other activities within the scope of promoting innovation, entrepreneurship and sustainable development, of mutual benefit to the Parties

3. By signing this MoU, the Associated Partner obtains the following rights:

- a. Becomes a member of the PROMETHEUS Network, with the role of Associated Partner.

- b. May use the PROMETHEUS / Associated Partner logo in activities and publications relevant to this MoU, stating their relation as Associated Partner where necessary.
 - c. Gets **access to the PROMETHEUS platforms and tools** that are or will become available for Associated Partners, based on the applicable PROMETHEUS policy. Such platforms and tools may include:
 - i. The PROMETHEUS Entrepreneurship Acceleration Platform
 - ii. The PROMETHEUS Intelligent Assistant
 - iii. The PROMETHEUS Training Platform
 - iv. The PROMETHEUS Knowledge Base
 - v. The PROMETHEUS Network Database
 - d. Gets access to PROMETHEUS innovation and entrepreneurship support **methodologies** that are or will become available for Associated Partners, based on the applicable PROMETHEUS policy. Such methodologies may include:
 - i. The PROMETHEUS Entrepreneurial Teaching Curricula
 - ii. The PROMETHEUS Entrepreneurial University Monitoring and Evaluation Framework
 - iii. The PROMETHEUS Challenge-Based Methods for Entrepreneurship Education
 - e. Gets access to PROMETHEUS project deliverables, based on the applicable PROMETHEUS policy.
 - f. Gets promotional access to PROMETHEUS **events and activities** that come at a cost for participants, based on the applicable PROMETHEUS policy. Such events may include:
 - i. The PROMETHEUS Digital Innovation and Entrepreneurship International Summer School
 - ii. The PROMETHEUS Vocational Education Programmes
 - iii. The PROMETHEUS Master Programmes
 - g. Will be considered for participation in joint proposals for funded projects that the PROMETHEUS Network will develop in the future.
 - h. Their Associated Partner status will be published and disseminated through the PROMETHEUS websites, social media and relevant publications.

 4. This MoU does not establish a legal partnership, joint venture, employment relationship, or relationship of agency between the Parties, nor binds the Parties to any financial commitment.
 5. The Parties acknowledge that terms and conditions for specific collaborative activity, including but not limited to financial, administrative, intellectual property, and legal terms, will be set forth in separate written (project) agreements, separate from this MoU, which need to be signed by authorised representatives of the Parties.
 6. Activities will be carried out without disclosure of either Party's confidential or proprietary information to the other Party or to third parties. Should it become necessary for the Parties to disclose confidential or

proprietary information, the providing Party will notify the receiving Party in advance in writing, and the Parties will agree on reasonable terms for the protection of such information. Any confidential information disclosed hereunder will be clearly marked or promptly disclosed in writing as 'Confidential'. Any confidential information disclosed orally and/or visually shall be confirmed as 'Confidential' in writing within thirty days after the date of oral and/or visual disclosure.

7. No person should be excluded from activities under this MoU on the basis of race, colour, gender, national origin, age, religion, genetic information, disability, veteran's status, sexual orientation, gender identity, or gender expression.
8. Each Party may not use the logo, registered or unregistered trademark, design or crest of the other Party outside the scope of the present MoU or in any way that would damage or bring into disrepute the name, image or reputation of the other Party.
9. The Parties shall seek to resolve any dispute that arises out of this MoU via good faith discussions with a view to maintaining the relationship of the Parties going forward.
10. Termination or expiry of this MoU will not affect any separate written (project) agreements between the Parties, which will be governed in accordance with their terms.
11. The term of this MoU commences on .../2021 and remains in force and effect for 2 years, unless it is earlier terminated by either Party, with written notice. This MoU may be renewed for subsequent periods by both Parties, with written communication.
