## What is proof of stake?

It is a mechanism that keeps the blockchain secure by validating the transactions and randomly offering the nodes that were used to validate the transaction a reward in the form of the transaction fee. To become a node on ethereum for example you need to have staked 32 eth and then you can get rewards for validating transactions. However you can also take part in staking in liquidity pools to then get rewards over time.
