Project Oplan Bawas Basura para sa Pondo ng Bawat Seksyon is a fund generating project which provides an avenue where FDPA community can conveniently dispose their recyclable trash goods and at the same time earn extra cash. Generally, the project aims to establish a specific and doable program to address waste management issues and concerns on the school campus. It aims to promote the continuation of proper solid waste management at home to all members of the school community, especially during this pandemic period.

Specifically, it aims to: a.) increase awareness and participation of learners and teachers in proper waste segregation as a sense of responsibility and proactive citizenship; b.) reduce a sufficient amount of solid waste disposed; c.) generate income as a source of classroom funds by selling recyclable wastes; d.) maximize the use of the school MRF (Material Recovery Facility) as storage of recyclables; and e.) develop the spirit of “Bayanihan” among learners in addressing waste management issues.

FDP school community members are encouraged to practice the 3R’s- Reduce, Reuse, and Recycle. Four properly labelled containers (one trash bin for each of the following: white papers, colored paper, plastic bottles, and residual wastes) for solid wastes are present in the 16 classrooms. During the regular RCE (Recyclables Collection Event), recyclables will be collected by the assigned YES-O officers and members every Friday of the week at 7:40 to 8:40. The collected recyclables are weighed and recorded. Finally, the properly packed recyclables are stored at the school MRF (Material Recovery Facility). Once the MRF has reached its 90% space, the partner scrap dealer of the school will come and buy the recyclables.

The project objectives were aligned with the school SIP (Enhanced School Improvement Plan) SY 2019-2022 under priority improvement areas such as maintaining cleanliness within the premises of PMA frequented by learners which aim to enhance the physical aspect of learning environment and engage learners in maintaining cleanliness of the environment.
