



CEVSOC Self-Nomination and Campaign Guidelines

AGM applications are open!! Please ensure you read the information and rules provided carefully.

- All applicants will be given the opportunity to give a speech at the AGM with a **one minute time limit**, for each of the roles they are applying for. If you are unable to attend the AGM but wish to nominate yourself for a position, please contact admin@cevsoc.com
- Candidates for the Co-President position will also have **Q&A session after their speeches**, run by the AGM moderators.
- All applicants for the Co-President positions will be offered an optional workshop, once their application is received, with the current Co-Presidents, to discuss their vision for 2024.
- Preferences for roles within your application are for public understanding only. Roles will be elected in the running order on the AGM Facebook event and the AGM Agenda. You will not be able to continue running for a further position if you have already been elected, despite preference order.
- All potential applicants are welcome to contact present Executive members via Facebook, the CEVSOC UNSW Facebook page or via email at admin@cevsoc.com if they have further questions about the positions.

The RULES for AGM candidacy are listed below. Failure to comply with these rules could result in your application being disqualified.

- Campaigning for positions **MAY NOT** begin until a candidate's application has been submitted.
- Some positions will require extra application materials (outlined in the application form).
- Candidates must behave with respect to others at all times. Commentary on a competing candidate's campaign for a position is allowed but must be presented in a respectful way.
- Both public and private social media campaigns (Facebook events) will be allowed.
- Three impartial moderators (**Maddie Clacy, Annikka Burge, Sadia Khaja**) have been assigned to moderate all campaign material. **All three must be added to campaign event pages as event owners.** If no event page is made for the campaign and a post is made instead, all three moderators must be tagged. Other social media platforms should be discussed with the moderators before any

campaigning commences. **Campaign specific questions may be sent to admin@cevsoc.com with the subject "AGM Moderators- {Issue}".**

- **Other UNSW promotional channels** such as the CEVSOC, UNSW Engineering or the EngSoc Facebook group/pages **cannot be used to promote individual candidates**. CEVSOC will however publish a list of candidates and their position applications.
- Candidates can only promote themselves and cannot endorse other candidates or run on a 'ticket' involving a group of candidates supporting each other in running for a set of positions.
- Content for campaigns (documents, promotional images, posts, event descriptions) and any other form of text **must be reviewed by at least two of the impartial moderators** before it is published by the candidate.
- Candidates are **not to enlist third parties** to publish content which circumvents the above rules.
- To be eligible to run for the position of **Co-President the candidate must have previously served** as either a member of committee or as part a member of one of the subcommittees or coordinator roles.
- There will be **zero tolerance if candidates break any of these rules**. Any candidates found to have done so will be disqualified from running for the AGM. If candidates can prove they have violated a rule accidentally, they will be allowed ONE strike before being disqualified, at the discretion of the moderators.
