**A. Purpose of the Agreement**

1.1 The purpose of this agreement is to outline the terms and conditions under which the player agrees to become a travel player for Legacy SC

1.2 By signing this agreement the player agrees to commit to play for Legacy SC for a specific period, with specific obligations and benefits expected on both sides for each other commitments

**B. Financials**

**Legacy Yearly Tuition:** \$1,200

**Payment Plan:** 12 monthly installments

**Monthly Payment:** \$100

**Due Date:** 28th of each month

- **The Player shall agree to pay a \$50 non refundable fee 1 week after the contract is signed.**
- **Uniform cost is \$100 Includes 3 shirts and sock Sleeves**

**C. Duties and Obligations**

2.1 The player agrees to practice and play with Legacy SC under the approved schedule

A. All schedules and times are subject to change based on availability of facilities

2.2 The player shall abide by all rules while attending practices, games and other Legacy events .All practices are mandatory

a. You must maintain 80% attendance each month

i. **Attendance Zones Policy**

To ensure player development and team commitment, attendance will be monitored and categorized into the following zones:

- **Green Zone – 80% or higher attendance**  
Players are in good standing and meeting program expectations.
- **Yellow Zone – 50% to 79% attendance**  
Players may be subject to follow-up meetings with the coach to address attendance and commitment.
- **Red Zone – Below 50% attendance**  
Players are considered not in good standing and may risk reduced playing time, suspension, or loss of roster spot at the coach's discretion.
- Attendance will be reviewed regularly and discussed during the required quarterly player meetings.

2.3 The player shall attend all game debriefs and film sessions that are scheduled

- a. Game debriefs will be counted towards your attendance monitoring

2.4 The player shall be respectful to all Coaches, managers and players

- a. You shall come to games and practices dressed and ready to perform ( legacy shirt, mid thigh length, socks and short)
- b. Cell phones will not be permitted in practice or games. All electronic devices shall be put away until the coach blows the final whistle for practice to end ( implement more)**
- c. You are to respect the coach's feedback. If at anytime you do not agree then you can meet with the coaches after practice to discuss your concerns
- d. You must have a professional and positive attitude during practices and games

**2.5 The player shall wear designated Jerseys and practice gear for practices and games**

- a. You must wear practice shirt , Black shorts ( thigh length), Black socks, shin guards and appropriate shoes to practice
- b. You must wear your game jersey. Black shorts, black socks and appropriate shoes to all games unless the coach says otherwise.

2.6 The player shall pay fees required by organization promptly

- a. All fees are to be paid by the player regardless if the player will not be in attendance for the game or tournaments.

2.7 The player shall attend all scheduled Tournaments and leagues unless the player has a reasonable excuse to miss the games.

- a. A player must notify the coaching staff in writing that they will not be in attendance for any games scheduled for the year 2026
- b. 2.8 The player shall agree to open a Legacy account to deposit monthly fees to cover practice space, tournament fees and other expenses as needed.

2.8 A monthly deposit of \$100 or more must be made by the 28th of each month

- a. A \$5 late fee will be assessed if payment is 3 days past due without contact. An additional \$5 will be added on if payment is not received within additional \$5 days without contact.
- b. If a player is late four (4) times, all future payments must be made on time. Failure to do so will result in a 30-day suspension and the player may forfeit their spot in any upcoming tournaments.**

2.9 The Player shall be obligated to Legacy SC. The player will not participate in outside soccer activities with other clubs until it has been discussed with their coach and has been given approval from the coach.

- a. If any player desires to be a guest, play for any other club or team. They must inform the coaching staff in writing.

#### **D. Legacy SC COMMITMENT TO YOU**

3.1 Prepare and provide theme-based training sessions.

3.2 Provide an organized approach to training.

3.3. Play our part in developing the “whole” individual through the medium of sports.

**E. PARENT/FAN SUPPORT**

4.1 Parents/fans understand that once the game begins, their role is to support/encourage the athletes and the coaches.

4.2 Parents/fans are not to interfere or undermine the game's play.

4.3 Parents must refrain from "sideline" coaching.

4.4 Parents are to refrain from speaking to the players during training sessions.

4.5 Parents who act in an unsportsmanlike manner or fail to abide by these rules risk having their child removed from the program by the coaching staff until the problem is corrected. Further action may be taken if necessary.

**F Player Development & Accountability (Year-Round)**

5.1 Players will meet with their coach quarterly to discuss individual progress

5.2 These meetings are mandatory

5.3 2 meetings will be in person

5.4 2 meetings will be conducted via Zoom

**G. Dismissal & Early Withdrawal Clause**

The parties acknowledge that this Agreement is binding for a twelve (12)-month term. If the Player and/or Parent/Guardian elects to withdraw from Legacy SC, or otherwise terminates this Agreement by choice prior to the end of the term, such withdrawal shall constitute an early termination of the Agreement.

**6.1 All fees for the full contract term shall remain due and payable** and are non-refundable, including any unpaid balances, installments, or assessments; and

**6.2 The Player must return all Legacy SC-issued uniforms and equipment** in good condition within seven (7) days of withdrawal. Failure to return issued items may result in replacement fees.

Legacy SC reserves the right to pursue collection of outstanding financial obligations and replacement costs in accordance with applicable policies and governing body rules.
