INTERPRETATION

1.1 In these Articles:-

- (a) **"the Academies"** means all the schools and educational institutions referred to in Article 4 and operated by the Company (and "Academy" means any one of those schools or educational institutions);
- (b) **"Academy Financial Year"** means the academic year from 1st of September to 31st of August of the following year;
- (c) **"the Articles"** means these Articles of Association of the Company (excluding, for the avoidance of doubt, any Scheme of Delegation which may be appended to these Articles or adopted by the Directors;
- (d) **"Chair"** means the chair of the Directors elected pursuant to Article 82 or 85;
- (e) **"Chief Executive Officer"** means such person as may be appointed by the Directors as the Chief Executive Officer of the Company;
- (f) **"Church of England Academies"** means all the schools falling within Article 4a(ii) and operated by the Company (and "Church of England Academy" shall mean any one of those schools);
- (g) **"clear days"** in relation to the period of a notice means the period excluding the day when the notice is given or deemed to be given and the day on which it is to take effect;
- (h) **"Clerk"** means the clerk to the Directors or any other person appointed to perform the duties of the clerk to the Directors, including a joint, assistant or deputy clerk;
- (i) **"Company"** means, save as otherwise defined at Article 6.9(a) in relation to Articles 6.2 to 6.8A, the company intended to be regulated by these Articles and referred to in Article 2;
- (j) **"Diocese"** means the Diocese of Oxford;
- (k) **"Diocesan Board of Education"** means the Oxford Diocesan Board of Education a registered charity with charity number 1133586 and a company limited by guarantee

and registered in England and Wales with company number 07071809 and any successor body;

- (l) **"Diocesan Director of Education"** means the chief officer of the Diocesan Board of Education;
- (m) **"Diocesan Members"** means the Diocesan Board of Education (being a corporate Member under Article 12(b)) and any person(s) appointed by the Diocesan Board of Education under Article 16B;
- (n) **"Directors"** means the directors of the Company (and "Director" means any one of those directors) subject to the definition of this term at Article 6.9(b) in relation to Articles 6.2-6.8A;
- (o) **"Financial Expert"** means an individual, company or firm who is authorised to give investment advice under the Financial Services and Markets Act 2000;
- (p) **"General Meeting"** means a meeting of the Members convened in accordance with these Articles;
- (q) **"Local Authority Associated Person"** means any person associated (within the meaning given in section 69(5) of the Local Government and Housing Act 1989) with any local authority by which the Company is influenced;
- (r) **"Local Governing Bodies"** means the committees appointed pursuant to Articles 100-102 and 104 (and "Local Governing Body" means any one of these committees);
- (s) **"the Measure"** means the Diocesan Boards of Education Measure 1991;
- (t) **"Member"** means a member of the Company and someone who as such is bound by the undertaking contained in Article 8;
- (u) **"the Memorandum"** means the Memorandum of Association of the Company;
- (v) **"Office"** means the registered office of the Company;
- (w) **"Parent Directors"** means those Directors elected or appointed pursuant to Articles 53 – 56 inclusive;
- (x) **"Parent Local Governor"** means the parent member of a Local Governing Body elected or appointed in accordance with Articles 53-56;
- (y) **"Principals"** means the head teachers of the Academies (and "Principal" means any one of these head teachers) ;
- (z) **"Principal Regulator"** means the body or person appointed as the Principal Regulator under the Charities Act 2011;
- (aa) **"Relevant Funding Agreement"** means the agreement or agreements entered into by the Company and the Secretary of State under section 1 of the Academies Act 2010 for the establishment of any Academy, including any variation or supplemental agreements thereof;

- (bb) **"Scheme of Delegation"** means an instrument by the Directors delegating such powers and responsibilities of the Directors as may be appropriate for them to delegate to the Local Governing Bodies consistently with the Object;
- (cc) **"the seal"** means the common seal of the Company if it has one;
- (dd) **"Secretary of State"** means the Secretary of State for Education or their successor;
- (ee) **"Special Educational Needs"** has the meaning set out in sections 20(1) and 21(2) of the Children and Families Act 2014;
- (ff) **"Teacher"** means a person employed under a contract of employment or a contract for services or otherwise engaged to provide his services as a teacher at one or more Academies;
- (gg) **"Trustees"** means those trustees holding the site of any of the Church of England Academies and providing it to the Company for use and occupation by that Academy;
- (hh) **"the United Kingdom"** means Great Britain and Northern Ireland;
- (ii) **"Vice-Chair"** means the vice-chair of the Directors elected pursuant to Article 82 or 85;
- (jj) words importing the masculine gender only shall include the feminine gender. Words importing the singular number shall include the plural number, and vice versa;
- (kk) subject as aforesaid, words or expressions contained in these Articles shall, unless the context requires otherwise, bear the same meaning as in the Companies Act 2006, as appropriate;
- (ll) any reference to a statute or statutory provision or measure shall include any statute or statutory provision or measure which replaces or supersedes such statute or statutory provision or measure including any modification or amendment thereto.

2 The company's name is River Learning Trust (and in this document it is called **"the Company"**).

3 The Company's registered office is to be situated in England and Wales.

OBJECT

4 The Company's objects (**"the Objects"**) are specifically restricted to the following:

- (a) to advance for the public benefit education in the United Kingdom, in particular but without prejudice to the generality of the foregoing by establishing, maintaining, carrying on, managing and developing schools offering a broad and balanced curriculum (**"the mainstream Academies"**) or educational institutions which are principally concerned with providing full-time or part-time education for children of compulsory school age who, by reason of illness, exclusion from school or otherwise, may not for any period receive suitable education unless alternative provision is made for them (**"the alternative provision Academies"**) or 16 to 19 Academies offering a curriculum appropriate to the needs of its students (**"the 16 to 19 Academies"**) or schools specially organised to make special educational provision for

pupils with Special Educational Needs ("the Special Academies") and which shall include:

- (i) Academies other than those designated Church of England, whether with or without a designated religious character; and
- (ii) Church of England Academies designated as such which shall be conducted in accordance with the principles, practices and tenets of the Church of England both generally and in particular in relation to arranging for religious education and daily acts of worship, and in having regard to any advice and following any directives issued by the Diocesan Board of Education, and

but in relation to each of the Academies to recognise and support their individual ethos, whether or not designated Church of England; and

- (b) as purely ancillary to (a) and not in relation to any Church of England Academy designated as such to:
 - (i) promote for the benefit of the inhabitants of the areas in which the Academies are situated the provision of facilities for recreation or other leisure time occupation of individuals who have need of such facilities by reason of their youth, age, infirmity or disablement, financial hardship or social and economic circumstances or for the public at large in the interests of social welfare and with the object of improving the condition of life of the inhabitants;
 - (ii) promote in the area in which the Academies are situated the physical, intellectual and social development of primarily but not exclusively children under five especially those who are socially and economically disadvantaged.

POWERS

5 In furtherance of the Objects but not further or otherwise the Company may exercise the following powers:

- (a) to draw, make, accept, endorse, discount, execute and issue promissory notes, bills, cheques and other instruments, and to operate bank accounts in the name of the Company;
- (b) to raise funds and to invite and receive contributions provided that in raising funds the Company shall not undertake any substantial permanent trading activities and shall conform to any relevant statutory regulations;
- (c) (subject to such further consents as may be required by law or as may be required from the Trustees as landlords/licensors where this is the case) to acquire, alter, improve and charge or otherwise dispose of property;
- (d) subject to Article 6.6-6.8 below to employ such staff, as are necessary for the proper pursuit of the Objects (including the maintenance of an effective Church of England ethos in relation to Church of England Academies) and to make all reasonable and necessary provision for the payments of pensions and superannuation to staff and their dependants;

- (e) to establish or support, whether financially or otherwise, any charitable companies, trusts, associations or institutions formed for all or any of the Objects;
- (f) to co-operate with other charities, other independent and maintained schools, academies and institutions within the further education sector, voluntary bodies and statutory authorities operating in furtherance of the Objects and to exchange information and advice with them;
- (g) to pay out of funds of the Company the costs, charges and expenses of and incidental to the formation and registration of the Company;
- (h) to establish, maintain, carry on, manage and develop the Academies at locations to be determined by the Directors;
- (i) to offer scholarships, exhibitions, prizes and awards to pupils and students and to former pupils and former students, and otherwise to encourage and assist the educational attainment of pupils and students and former pupils and former students;
- (j) to provide educational facilities and services to students of all ages and the wider community for the public benefit;
- (k) to carry out research into the development and application of new techniques in education and to their approach to curriculum development and delivery and to publish the results of such research, and to develop means of benefiting from application of the experience of industry, commerce, other schools, educational institutions and the voluntary sector to the education of pupils and students in academies;
- (l) subject to such consents as may be required from the Trustees or otherwise required by law and/or by any contract entered into by or on behalf of the Company, to borrow and raise money for the furtherance of the Objects in such manner and on such security as the Company may think fit;
- (m) to deposit or invest any funds of the Company not immediately required for the furtherance of its Objects (but to invest only after obtaining such advice from a Financial Expert as the Directors consider necessary and having regard to the suitability of investments and the need for diversification);
- (n) to delegate the management of investments to a Financial Expert, but only on terms that:
 - (i) the investment policy is set down in writing for the Financial Expert by the Directors;
 - (ii) every transaction is reported promptly to the Directors;
 - (iii) the performance of the investments is reviewed regularly with the Directors;
 - (iv) the Directors are entitled to cancel the delegation arrangement at any time;
 - (v) the investment policy and the delegation arrangement are reviewed at least once a year;

- (vi) all payments due to the Financial Expert are on a scale or at a level which is agreed in advance and are notified promptly to the Directors on receipt; and
- (vii) the Financial Expert must not do anything outside the powers of the Directors;
- (o) to arrange for investments or other property of the Company to be held in the name of a nominee company acting under the control of the Directors or of a Financial Expert acting under their instructions, and to pay any reasonable fee required;
- (p) to provide indemnity arrangements to Directors, Trustees and the members of Local Governing Bodies in accordance with, and subject to the conditions of section 232 to 235 of the Companies Act 2006, section 189 of the Charities Act 2011 or any other provision of law applicable to charitable companies and any such indemnity is limited accordingly;
- (q) subject in respect of any use of their property to such consents as may be required from the Trustees and to any terms and conditions the Trustees may require to establish subsidiary companies to carry on any trade or business for the purpose of raising funds for the Company;
- (r) to discharge any liability necessarily incurred by the Trustees to further the purposes of the Company; and
- (s) to do all such other lawful things as are necessary for or are incidental to or conducive to the achievement of the Objects and appropriate to the religious character of any Academy including entering into any protocol, arrangement or agreement with the Diocesan Board of Education in relation to the exercise of powers and discharge of functions under the Measure.

APPLICATION OF INCOME AND PROPERTY

- 6.1 The income and property of the Company shall be applied solely towards the promotion of the Objects.

MEMBERS' BENEFITS AND CONFLICTS OF INTEREST

- 6.2 None of the income or property of the Company may be paid or transferred directly or indirectly by way of dividend bonus or otherwise by way of profit to any Member. Nonetheless a Member who is not also a Director may:
- (a) benefit as a beneficiary of the Company;
 - (b) be paid reasonable and proper remuneration for any goods or services supplied to the Company;
 - (c) be paid rent for premises let by the Member if the amount of the rent and other terms of the letting are reasonable and proper; and
 - (d) be paid interest on money lent to the Company at a reasonable and proper rate, such rate not to exceed 2 per cent per annum below the base lending rate of a UK clearing bank selected by the Directors, or 0.5%, whichever is the higher.

- 6.2A The Directors may only rely upon the authority provided by Article 6.2 to allow a benefit to a Member if each of the following conditions is satisfied:
- (a) the remuneration or other sums paid to the Member do not exceed an amount that is reasonable in all the circumstances; and
 - (b) the Directors are satisfied that it is in the interests of the Company to contract with that Member rather than with someone who is not a Member. In reaching that decision the Directors must balance the advantage of contracting with a Member against the disadvantages of doing so ; and
 - (c) the reason for their decision is recorded by the Directors in the minute book.

DIRECTORS' AND TRUSTEES' INDEMNITY

- 6.3 A Director and a Trustee may benefit from any indemnity arrangement purchased at the Company's expense, or any arrangement so agreed with the Secretary of State to cover the liability of the Directors and the Trustees which by virtue of any rule of law would otherwise attach to them in respect of any negligence, default or breach of trust or breach of duty of which they may be guilty in relation to the Company or to any trust of any Academy site: provided that any such arrangement shall not extend to:
- (i) any claim arising from any act or omission which Directors or Trustees (or any of them) knew to be a breach of trust (including a breach of any trust relating to any Academy site) or breach of duty or which was committed by the Directors or Trustees (or any of them) in reckless disregard to whether it was a breach of trust or breach of duty or not; and
 - (ii) the costs of any unsuccessful defence to a criminal prosecution brought against the Directors or Trustees (or any of them) in their capacity as directors of the Company or as Trustees of any Academy site.

Further, this Article does not authorise a Director or Trustee to benefit from any indemnity arrangements that would be rendered void by any provision of the Companies Act 2006, the Charities Act 2011 or any other provision of law.

DIRECTORS' BENEFITS AND CONFLICTS OF INTEREST

- 6.4 A public company, which has shares listed on a recognised stock exchange and of which any one Director holds no more than 1% of the issued capital of that company, may receive fees, remuneration or other benefit in money or money's worth from the Company.
- 6.5 A Director may at the discretion of the Directors be reimbursed from the property of the Company for reasonable expenses properly incurred by him or her when acting on behalf of the Company, but excluding expenses in connection with foreign travel.
- 6.6 No Director may:
- (a) buy any goods or services from the Company;
 - (b) sell goods, services, or any interest in land to the Company;

- (c) be employed by, or receive any remuneration from the Company (other than the Chief Executive Officer (to the extent that he or she is a Director) whose employment and/or remuneration is subject to the procedure and conditions in Article 6.8); or
- (d) receive any other financial benefit from the Company:

unless:

- (i) the payment is permitted by Article 6.7 and the Directors follow the procedure and observe the conditions set out in Article 6.8; or
- (ii) the Directors obtain the prior written approval of the Charity Commission and fully comply with any procedures it prescribes.

6.7 Subject to Article 6.8, a Director may:

- (a) receive a benefit from the Company in the capacity of a beneficiary of the Company;
- (b) be employed by the Company or enter into a contract for the supply of goods or services to the Company, other than for acting as a Director;
- (c) receive interest on money lent to the Company at a reasonable and proper rate not exceeding 2% per annum below the base rate of a clearing bank to be selected by the Directors, or 0.5%, whichever is the higher; and
- (d) receive rent for premises let by the Director to the Company if the amount of the rent and the other terms of the lease are reasonable and proper.

6.8 The Company and its Directors may only rely upon the authority provided by Article 6.7 if each of the following conditions is satisfied:

- (a) the remuneration or other sums paid to the Director do not exceed an amount that is reasonable in all the circumstances; and
- (b) the Director is absent from the part of any meeting at which there is discussion of:
 - (i) his or her employment, remuneration, or any matter concerning the contract, payment or benefit; or
 - (ii) his or her performance in the employment, or his or her performance of the contract; or
 - (iii) any proposal to enter into any other contract or arrangement with him or her or to confer any benefit upon him or her that would be permitted under Article 6.7; or
 - (iv) any other matter relating to a payment or the conferring of any benefit permitted by Article 6.7; and
- (c) the Director does not vote on any such matter and is not to be counted when calculating whether a quorum of Directors is present at the meeting; and
- (d) in relation to proposed contracts for employment or services (except, where the Chief Executive Officer is a Director, the principal employment contract or contract for services under which he or she is employed or engaged by the Company), the

other Directors are satisfied that it is in the interests of the Company to employ or to contract with that Director rather than with someone who is not a Director. In reaching that decision the Directors must balance the advantage of employing or contracting with a Director against the disadvantages of doing so (especially the loss of the Director's services as a result of dealing with the Director's conflict of interest); and

- (e) the reason for their decision is recorded by the Directors in the minute book; and
- (f) a majority of the Directors then in office have received no such payments or benefit.

6.8A The provision in Article 6.6(c) that no Director may be employed by or receive any remuneration from the Company (other than the Chief Executive Officer to the extent he or she is a Director) does not apply to an employee of the Company who is subsequently elected or appointed as a Director save that this Article shall only allow such a Director to receive remuneration or benefit from the Company in his or her capacity as an employee of the Company and provided that the procedure as set out in Articles 6.8(b) and 6.8(c) is followed.

6.9 In Articles 6.2 - 6.8A:

- (a) "Company" shall include any company in which the Company:
 - holds more than 50% of the shares; or
 - controls more than 50% of the voting rights attached to the shares; or
 - has the right to appoint one or more directors to the board of the company;
- (b) "Director" shall include any child, stepchild, parent, grandchild, grandparent, brother, sister or spouse of the Director or any person living with the Director as his or her partner; and
- (c) the employment or remuneration of a Director includes the engagement or remuneration of any firm or company in which the Director is:
 - (i) a partner;
 - (ii) an employee;
 - (iii) a consultant;
 - (iv) a director;
 - (v) a member; or
 - (vi) a shareholder, unless the shares of the company are listed on a recognised stock exchange and the Director holds less than 1% of the issued capital.

LIMITED LIABILITY OF MEMBERS

7 The liability of the Members is limited.

DISSOLUTION AND WINDING UP

- 8 Every Member undertakes to contribute such amount as may be required (not exceeding £10) to the Company's assets if it should be wound up while he or she is a Member or within one year after he or she ceases to be a Member, for payment of the Company's debts and liabilities before he or she ceases to be a Member, and of the costs, charges and expenses of winding up, and for the adjustment of the rights of the contributories among themselves.
- 9 If the Company is wound up or dissolved and after all its debts and liabilities (including any under section 2 of the Academies Act 2010) have been satisfied there remains any property it shall not be paid to or distributed among the Members (except for a Member which is itself a charity fulfilling the criteria set out below), but shall be given or transferred to some other charity or charities having objects similar to the Objects which prohibits the distribution of its or their income and property to an extent at least as great as is imposed on the Company by Article 6 above, chosen by the Members at or before the time of dissolution and if that cannot be done then to some other charitable object.

AMENDMENTS TO MEMORANDUM AND ARTICLES

- 10 No alteration or addition shall be made to or in the provisions of the Articles without the written consent of the Diocesan Board of Education.
- 11 No alteration or addition shall be made to or in the provisions of the Articles which would have the effect (a) that the Company would cease to be a company to which section 60 of the Companies Act 2006 applies; or (b) that the Company would cease to be a charity; or (c) that it might weaken the maintenance of the ethos (whether Church of England or otherwise) at the Academies.

MEMBERS

- 12 The Members of the Company shall comprise:
- (a) the individuals who are Members on the date these Articles are adopted, provided that they are subject to the same terms as other Members when it comes to no longer being a Member;
 - (b) the Diocesan Board of Education acting in its corporate capacity by the hand of the Diocesan Director of Education or otherwise as it shall direct;
 - (c) the Chair;
 - (d) any person appointed by the Diocesan Board of Education under Article 16B; and
 - (e) any person appointed under Articles 15A and/or 16A,

provided that at any time the minimum number of Members shall not be less than three.

- 12A An employee of the Company cannot be a Member of the Company.
- 13 Each person entitled to appoint Members in Article 12 shall have the right from time to time by written notice delivered to the Office to remove any Member appointed by them and to appoint a replacement Member to fill a vacancy whether resulting from such removal or otherwise.

14 If any of the persons entitled to appoint Members in Article 12:

- (a) in the case of an individual, dies or becomes legally incapacitated;
- (b) in the case of a corporate entity, ceases to exist and is not replaced by a successor institution;
- (c) becomes insolvent or makes any arrangement or composition with its creditors generally; or
- (d) ceases to themselves be a Member,

their right to appoint Members under these Articles shall vest in the remaining Members.

15 Membership will terminate automatically if:

- (a) a Member (which is a corporate entity) ceases to exist and is not replaced by a successor institution;
- (b) a Member (who is an individual) dies or becomes incapable by reason of illness or injury of managing and administering his or her own affairs;
- (c) a Member becomes insolvent or makes any arrangement or composition with that Member's creditors generally; or
- (d) a Member, who became a Member further to Article 12(c), ceases to be the Chair.

15A The Members, with the written consent of the Diocesan Board of Education, may agree by passing a special resolution to appoint such additional Members as they think fit.

16 In addition to their rights under to Article 13 and subject to the requirements of the Relevant Funding Agreement, the Members may agree by passing a special resolution to remove any Member(s) save that this provision shall not apply to the Diocesan Board of Education (being a corporate Member under Article 12 (b)) or to Members appointed under Article 16B. The Member(s) whose proposed removal is/are the subject of the written resolution shall not be entitled to vote on that resolution.

16A Upon the resignation or removal of any Member (including a signatory to the Memorandum) other than the Diocesan Board of Education or a Member appointed by the Diocesan Board of Education the Members shall appoint by majority a replacement Member if required to ensure that the number of Diocesan Members shall not exceed 25% of the total number of Members.

16B If the number of Diocesan Members is less than 25% of the total number of Members the Diocesan Board of Education may appoint additional Members provided that the total proportion of Diocesan Members does not exceed 25% of the total number of Members.

16C In exercising their rights under these Articles and the Companies Act 2006, the Members shall not do any thing or take any action which would cause the Company to contravene its Objects.

17 Every person nominated to be a Member of the Company shall either sign a written consent to become a Member or sign the register of Members on becoming a Member.

- 18 Any individual (but not corporate) Member may resign provided that after such resignation the number of Members is not less than three. A Member shall cease to be one immediately on the receipt by the Company of a notice in writing signed by the person or persons entitled to remove him or her under Articles 13 or 16 provided that no such notice shall take effect when the number of Members is less than three unless it contains or is accompanied by the appointment of a replacement Member.
- 18A The Diocesan Board of Education is not precluded by its membership of the Company from taking any action or exercising any function it has as a body constituted under the Measure for the Diocese.

GENERAL MEETINGS

- 19 Not used.
- 20 The Directors may call General Meetings and on the requisition of Members pursuant to the provisions of the Companies Act 2006 shall forthwith proceed to convene a General Meeting in accordance with that Act. If there are not within the United Kingdom sufficient Directors to call a General Meeting, any Director or any Member may call a General Meeting.

NOTICE OF GENERAL MEETINGS

- 21 General Meetings shall be called by at least fourteen clear days' notice but may be called by shorter notice if it is so agreed by a majority in number of Members having a right to attend and vote and together representing not less than 90% of the total voting rights at that meeting.
- 21A The notice shall specify the time and place of the meeting and the general nature of the business to be transacted. The notice shall also state that the Member is entitled to appoint a proxy. The notice shall be given to all the Members, all Directors and the auditors.
- 22 The accidental omission to give notice of a meeting to, or the non-receipt of notice of a meeting by, any person entitled to receive notice shall not invalidate the proceedings at that meeting.

PROCEEDINGS AT GENERAL MEETINGS

- 23 No business shall be transacted at any meeting unless a quorum is present. A Member counts towards the quorum by being present either in person or by proxy. Two persons entitled to vote upon the business to be transacted, each being a Member or a proxy of a Member or a duly authorised representative of a corporate Member shall constitute a quorum.
- 24 If a quorum is not present within half an hour from the time appointed for the meeting, or if during a meeting a quorum ceases to be present, the meeting shall stand adjourned to the same day in the next week at the same time and place or to such time and place as the Directors may determine.
- 25 The Members present and entitled to vote at the meeting shall elect by ordinary resolution one of their number to be the chair of the General Meeting, and such election shall be binding on all Members and Directors present at the meeting.
- 26 Not used.

- 27 A Director shall, notwithstanding that he or she is not a Member, be entitled to attend and speak at any General Meeting .
- 28 The chair may, with the consent of a majority of the Members at a meeting at which a quorum is present (and shall if so directed by the meeting), adjourn the meeting from time to time and from place to place, but no business shall be transacted at any adjourned meeting other than the business which might properly have been transacted at the meeting had the adjournment not taken place. When a meeting is adjourned for fourteen days or more, at least seven clear days' notice shall be given specifying the time, date and place of the adjourned meeting and the general nature of the business to be transacted. Otherwise it shall not be necessary to give any such notice.
- 29 A resolution put to the vote of the meeting shall be decided on a show of hands unless before, or on the declaration of the result of the show of hands, a poll is duly demanded. Subject to the provisions of the Companies Act 2006, a poll may be demanded:
- (a) by the chair; or
 - (b) by at least two Members having the right to vote at the meeting; or,
 - (c) by a Member or Members representing not less than one-tenth of the total voting rights of all the Members having the right to vote at the meeting.
- 30 Unless a poll is duly demanded a declaration by the chair that a resolution has been carried or carried unanimously, or by a particular majority, or lost, or not carried by a particular majority and an entry to that effect in the minutes of the meeting shall be conclusive evidence of the fact without proof of the number or proportion of the votes recorded in favour of or against such resolution.
- 31 The demand for a poll may be withdrawn, before the poll is taken, but only with the consent of the chair. The withdrawal of a demand for a poll shall not invalidate the result of a show of hands declared before the demand for the poll was made.
- 32 A poll shall be taken as the chair directs and he or she may appoint scrutineers (who need not be Members) and fix a time, date and place for declaring the results. The result of the poll shall be deemed to be the resolution of the meeting at which the poll was demanded.
- 33 A poll demanded on the election of the chair or on a question of adjournment shall be taken immediately. A poll demanded on any other question shall be taken either immediately or at such time, date and place as the chair directs not being more than thirty days after the poll is demanded. The demand for a poll shall not prevent continuance of a meeting for the transaction of any business other than the question on which the poll is demanded. If a poll is demanded before the declaration of the result of a show of hands and the demand is duly withdrawn, the meeting shall continue as if the demand had not been made.
- 34 No notice need be given of a poll not taken immediately if the time, date and place at which it is to be taken are announced at the meeting at which it is demanded. In other cases at least seven clear days' notice shall be given specifying the time, date and place at which the poll is to be taken.
- 35 A resolution in writing agreed by such number of Members as required if it had been proposed at a General Meeting shall be as effectual as if it had been passed at a General Meeting duly convened and held provided that a copy of the proposed resolution has been

sent to every Member. The resolution may consist of several instruments in the like form each agreed by one or more Members.

VOTES OF MEMBERS

- 36 On the show of hands every Member present in person shall have one vote. On a poll every Member present in person or by proxy shall have one vote.
- 37 Not used.
- 38 No Member shall be entitled to vote at any General Meeting unless all monies then payable by him or her to the Company have been paid.
- 39 No objections shall be raised to the qualification of any person to vote at any General Meeting except at the meeting or adjourned meeting at which the vote objected to is tendered, and every vote not disallowed at the meeting shall be valid. Any objection made in due time shall be referred to the chair whose decision shall be final and conclusive.
- 40 An instrument appointing a proxy shall be in writing, signed by or on behalf of the appointer and shall be in the following form (or in a form as near thereto as circumstances allow or in any other form which is usual or which the Directors may approve) -

"I/We,, of, being a Member/Members of the above named Company, hereby appoint of, or in his or her absence, of as my/our proxy to attend, speak and vote in my/our name[s] and on my/our behalf at the General Meeting of the Company to be held on20[], and at any adjournment thereof.

Signed on 20[]"

- 41 Where it is desired to afford Members an opportunity of instructing the proxy how he or she shall act the instrument appointing a proxy shall be in the following form (or in a form as near thereto as circumstances allow or in any other form which is usual or which the Directors may approve) -

"I/We,, of, being a Member/Members of the above-named Company, hereby appoint of, or in his or her absence, of, as my/our proxy to attend, speak and vote in my/our name[s] and on my/our behalf at the General Meeting of the Company, to be held on 20[], and at any adjournment thereof.

This form is to be used in respect of the resolutions mentioned below as follows:

Resolution No. 1 *for * against

Resolution No. 2 *for * against.

* Strike out whichever is not desired.

Unless otherwise instructed, the proxy may vote as he or she thinks fit or abstain from voting,

- 42 The instrument appointing a proxy and any authority under which it is signed or a copy of such authority certified by a notary or in some other way approved by the Members may:
- (a) be deposited at the Office or at such other place within the United Kingdom as is specified in the notice convening the meeting or in any instrument of proxy sent out

by the Company in relation to the meeting not less than 48 hours before the time for holding the meeting or adjourned meeting at which the person named in the instrument proposes to vote, or

- (b) in the case of a poll taken more than 48 hours after it is demanded, be deposited as aforesaid after the poll has been demanded and not less than 24 hours before the time appointed for the taking of the poll; or
- (c) where the poll is not taken forthwith but is taken not more than 48 hours after it was demanded, be delivered at the meeting at which the poll was demanded to the chair or to the Clerk or to any Director,

and an instrument of proxy which is not deposited or delivered in a manner so permitted shall be invalid.

- 43 A vote given or poll demanded by proxy or by the duly authorised representative of a corporation shall be valid notwithstanding the previous determination of the authority of the person voting or demanding a poll unless notice of the determination was received by the Company at the Office or at such other place at which the instrument of proxy was duly deposited before the commencement of the meeting or adjourned meeting at which the vote given or the poll demanded or (or in the case of a poll taken otherwise than on the same day as the meeting or adjourned meeting) the time appointed for taking the poll.
- 44 Any organisation which is a Member may by resolution of its board of directors or other governing body authorise such person as it thinks fit to act as its representative at any meeting of the Company, and the person so authorised shall be entitled to exercise the same powers on behalf of the organisation which he or she represents as that organisation could exercise if it were an individual Member.

DIRECTORS

- 45 The number of Directors shall be not less than five nor more than twelve.
- 45A All Directors upon their appointment or election and before exercising any duties as a Director shall give a written undertaking to the Trustees and the Diocesan Board of Education to uphold the Object of the Company.
- 46 Subject to Articles 45, 49 and 53, the Company shall have the following Directors:
 - (a) up to twelve Directors, appointed under Articles 50 and 50A combined;
 - (b) a minimum of 2 Parent Directors elected or appointed under Articles 53-56 in the event that no Local Governing Bodies are established under Article 100(a) or if no provision is made, or is planned, for at least 2 Parent Local Governors on each established Local Governing Body pursuant to Article 101A; and
 - (c) the Chief Executive Officer, if he or she agrees and is appointed by the Members under Article 57.
- 47 The Company may also have any Co-opted Directors appointed under Article 58.
- 48 Not used.
- 49 Future Directors shall be appointed or elected, as the case may be, under these Articles. Where it is not possible for such a Director to be appointed or elected due to the fact that an

Academy has not yet been established, then the relevant Article or part thereof shall not apply.

APPOINTMENT OF DIRECTORS

- 50 The Members may appoint by ordinary resolution up to nine Directors.
- 50A The Diocesan Board of Education may appoint up to three Directors) provided that the total number of Directors appointed under this Article shall not exceed 25% of the total number of Directors
- 50B The total number of Directors, including the Chief Executive Officer if they are appointed as a Director under Article 57, who are employees of the Company shall not exceed one third of the total number of Directors.
- 51 Not used.
- 52 Not used.

PARENT DIRECTORS

- 53 In circumstances where the Directors have not appointed Local Governing Bodies in respect of the Academies as envisaged in Article 100(a) or if no provision is made for at least 2 Parent Local Governors on each established Local Governing Body pursuant to Article 101A there shall be a minimum of two Parent Directors and otherwise such number as the Members shall decide who shall be appointed or elected in accordance with Articles 54 - 56.
- 54 Parent Directors and Parent Local Governors shall be elected or, if the number of parents, or individuals exercising parental responsibility, standing for election is less than the number of vacancies, appointed (in accordance with the terms of reference determined by the Directors from time to time). The elected or appointed Parent Directors must be a parent, or an individual exercising parental responsibility, of a registered pupil at one or more of the Academies at the time when he or she is elected or appointed. The elected (or, if the number of parents or individuals exercising parental responsibility standing for election is less than the number of vacancies, appointed) Parent Local Governors of the Local Governing Body must be a parent, or an individual exercising parental responsibility, of a registered pupil at one or more of the Academies overseen by the Local Governing Body at the time when he or she is elected or appointed.
- 54AA In the case of 16-19 Academies, references to 'a parent, or an individual exercising parental responsibility, of a registered pupil at one or more of the Academies' in Article 54 shall be deemed to be references to 'a parent or an individual exercising parental responsibility of, a registered student at that 16-19 Academy' or, in circumstances where no parent, or an individual exercising parental responsibility, of a registered student at the 16-19 Academy is willing or able to act as a Parent Director or a Parent Local Governor, references to 'a parent, or an individual exercising parental responsibility, of a registered pupil at one or more of the Academies' shall be deemed to be references to 'a parent, or an individual exercising parental responsibility, of a child of above compulsory school age but not above the age of 19.
- 54A If the number of parents standing for election is less than or equal to the number of vacancies no election shall be necessary and the Directors shall appoint the parents standing for election as Parent Directors or Parent Local Governors. The number of Parent Directors and Parent Local Governors required shall be made up by Parent Directors and Parent Local

Governors appointed by the Directors if the number of parents, or individuals exercising parental responsibility, standing for election is less than the number of vacancies.

- 55 The Directors shall make all necessary arrangements for, and determine all other matters relating to, an election of the Parent Directors or Parent Local Governors, including any question of whether a person is a parent, or an individual exercising parental responsibility, of a registered pupil at one of the Academies. Any election of the Parent Directors or Parent Local Governors which is contested shall be held by secret ballot. For the purposes of any election of Parent Local Governors, any parent, or an individual exercising parental responsibility, of a registered pupil at the Academies overseen by the Local Governing Body shall be eligible to vote.
- 56 In appointing a Parent Director or Parent Local Governor the Directors shall appoint a person who is the parent, or an individual exercising parental responsibility, of a registered pupil at an Academy as described in Articles 54 and 54AA; or where the Directors are exercising their power to appoint a Parent Director or Parent Local Governor and it is not reasonably practical to appoint a parent, or an individual exercising parental responsibility, as described in Articles 54 and 54AA, then the Directors may appoint a person who is the parent, or an individual exercising parental responsibility, of a child within the age range of at least one of the Academies or, in the case of an appointment to a Local Governing Body, the age range of at least one of the Academies overseen by that Local Governing Body.

CHIEF EXECUTIVE OFFICER

- 57 Providing that the Chief Executive Officer agrees so to act, the Members may by ordinary resolution appoint the Chief Executive Officer as a Director.

CO-OPTED DIRECTORS

- 58 Subject to Article 45, the Directors may appoint up to two Co-opted Directors for such term (not exceeding four years) and otherwise upon such conditions as they shall think fit.. A 'Co-opted Director' means a person who is appointed to be a Director by being co-opted by Directors who have not themselves been so appointed. The Directors may not co-opt an employee of the Company as a Co-opted Director if thereby the number of Directors who are employees of the Company would exceed one third of the total number of Directors including the Chief Executive Officer to the extent he or she is a Director.

59 - 63 Not used.

TERM OF OFFICE

- 64 The term of office for any Director (other than Co-opted Directors under Article 58) shall be four years, save that this time limit shall not apply to any post which is held ex-officio. Subject to remaining eligible to be a particular type of Director, any Director may be re-appointed or re-elected in accordance with these Articles.

RESIGNATION AND REMOVAL

- 65 A Director shall cease to hold office if he or she resigns his or her office by notice to the Company (but only if at least three Directors will remain in office when the notice of resignation is to take effect).

- 66 A Director shall cease to hold office if he or she is removed by the person or persons who appointed or elected him or her, or otherwise by ordinary resolution of the Members in accordance with the Companies Act 2006.
- 67 Where a Director resigns his or her office or is removed from office, the Director or, where he or she is removed from office, those removing him or her, shall give written notice thereof to the Clerk.

DISQUALIFICATION OF DIRECTORS

- 68 No person shall be qualified to be a Director unless he or she is aged 18 or over at the date of his or her election or appointment. No current pupil or current student of any Academy shall be a Director.
- 69 A Director shall cease to hold office if he or she becomes incapable by reason of illness or injury of managing or administering his or her own affairs.
- 70 A Director shall cease to hold office if he or she is absent without the permission of the Directors from all their meetings held within a period of six months and the Directors resolve that his or her office be vacated.
- 71 A person shall be disqualified from holding or continuing to hold office as a Director if:
- (a) he or she has been declared bankrupt and/or his or her estate has been seized from his or her possession for the benefit of his or her creditors and the declaration or seizure has not been discharged, annulled or reduced; or
 - (b) he or she is the subject of a bankruptcy restrictions order or an interim order.
- 72 A person shall be disqualified from holding or continuing to hold office as a Director at any time when he or she is subject to a disqualification order or a disqualification undertaking under the Company Directors Disqualification Act 1986 or to an order made under section 429(2)(b) of the Insolvency Act 1986 (failure to pay under county court administration order).
- 73 A Director shall cease to hold office if he or she ceases to be a Director by virtue of any provision in the Companies Act 2006, is disqualified from acting as a trustee by virtue of section 178 of the Charities Act 2011 (or any statutory re-enactment or modification of that provision), or is otherwise found to be unsuitable by the Secretary of State under the provisions of the Relevant Funding Agreements.
- 74 A person shall be disqualified from holding or continuing to hold office as a Director if he or she has been removed from the office of director or trustee for a charity by an order made by the Charity Commission or the High Court on the grounds of any misconduct or mismanagement in the administration of the charity for which he or she were responsible or to which he or she was privy, or which he or she by his or her conduct contributed to or facilitated.
- 75 A person shall be disqualified from holding or continuing to hold office as a Director or a member of a Local Governing Body if he has not given the undertaking required by Article 45A (or Article 103) as applicable.
- 76 Not used.

Church of England model articles for Academy Trusts (the "Company") where the Church is in a minority (i.e. "VC" model)

- 77 A person shall be disqualified from holding or continuing to hold office as a Director where he or she has, at any time, been convicted of any criminal offence, excluding any that have been spent under the Rehabilitation of Offenders Act 1974 as amended, and excluding any offence for which the maximum sentence is a fine or a lesser sentence except where a person has been convicted of any offence which falls under section 178 of the Charities Act 2011.
- 78 A person shall be disqualified from holding or continuing to hold office as a Director if he or she has not provided to the Chair a criminal records certificate at an enhanced disclosure level under section 113B of the Police Act 1997. In the event that the certificate discloses any information which would in the opinion of either the Chair or the Chief Executive Officer confirm their unsuitability to work with children that person shall be disqualified. If a dispute arises as to whether a person shall be disqualified, a referral shall be made to the Secretary of State to determine the matter. The determination of the Secretary of State shall be final.
- 79 Where, by virtue of these Articles a person becomes disqualified from holding, or continuing to hold office as a Director; and he or she is, or is proposed, to become such a Director, he or she shall upon becoming so disqualified give written notice of that fact to the Clerk.
- 80 Articles 68 to 75, Articles 77 to 79 and Articles 97 to 98B also apply to any member of any committee of the Directors, including a Local Governing Body, who is not a Director.

CLERK TO THE DIRECTORS

- 81 The Clerk shall be appointed by the Directors for such term, at such remuneration and upon such conditions as they may think fit; and any Clerk so appointed may be removed by them. The Clerk shall not be a Director, the Chief Executive Officer or a Principal. Notwithstanding this Article, the Directors may, where the Clerk fails to attend a meeting of theirs, appoint any one of their number or any other person to act as Clerk for the purposes of that meeting. The Clerk may, but need not, be the appointed company secretary of the Company.

CHAIR AND VICE-CHAIR OF THE DIRECTORS

- 82 The Directors shall for each school year elect a Chair and a Vice-Chair from among their number. A Director who is employed by the Company shall not be eligible for election as Chair or Vice-Chair.
- 83 Subject to Article 84, the Chair or Vice-Chair shall hold office as such until his or her successor has been elected in accordance with Article 85.
- 84 The Chair or Vice-Chair may at any time resign his or her office by giving notice in writing to the Clerk. The Chair or Vice-Chair shall cease to hold office if:
- (a) he or she ceases to be a Director;
 - (b) he or she is employed by the Company;
 - (c) he or she is removed from office in accordance with these Articles; or
 - (d) in the case of the Vice-Chair, he or she is elected in accordance with these Articles to fill a vacancy in the office of the Chair.

Church of England model articles for Academy Trusts (the "Company") where the Church is in a minority (i.e. "VC" model)

- 85 Where by reason of any of the matters referred to in Article 84, a vacancy arises in the office of Chair or Vice-Chair, the Directors shall at their next meeting elect one of their number to fill that vacancy.
- 86 Where the Chair is absent from any meeting or there is at the time a vacancy in the office of the Chair, the Vice-Chair shall act as the Chair for the purposes of the meeting.
- 87-89 Not used.
- 90 The Directors may remove the Chair or Vice-Chair from office in accordance with these Articles.
- 91 A resolution to remove the Chair or Vice-Chair from office which is passed at a meeting of the Directors shall not have effect unless:
- (a) it is confirmed by a resolution passed at a second meeting of the Directors held not less than fourteen days after the first meeting; and
 - (b) the matter of the Chair's or Vice-Chair's removal from office is specified as an item of business on the agenda for each of those meetings.
- 92 Before the Directors resolve at the relevant meeting on whether to confirm the resolution to remove the Chair or Vice-Chair from office, the Director or Directors proposing his or her removal shall at that meeting state their reasons for doing so and the Chair or Vice-Chair shall be given an opportunity to make a statement in response.

POWERS OF DIRECTORS

- 93 Subject to provisions of the Companies Act 2006, the Articles and to any directions of the Members given by special resolution, the business of the Company shall be managed by the Directors who may exercise all the powers of the Company. No alteration of the Articles and no such direction shall invalidate any prior act of the Directors which would have been valid if that alteration had not been made or that direction had not been given. The powers given by this Article shall not be limited by any special power given to the Directors by the Articles and a meeting of Directors at which a quorum is present may exercise all the powers exercisable by the Directors.
- 94 In addition to all powers hereby expressly conferred upon them and without detracting from the generality of their powers under the Articles the Directors shall have the following powers, namely:
- (a) to expend the funds of the Company in such manner as they shall consider most beneficial for the achievement of the Objects and to invest in the name of the Company such part of the funds as they may see fit and to direct the sale or transposition of any such investments and to expend the proceeds of any such sale in furtherance of the Objects;
 - (b) to enter into contracts on behalf of the Company.
- 95 In the exercise of their powers and functions, the Directors may consider any advice given by the Chief Executive Officer (to the extent that he or she is not a Director) and any other executive officer.

Church of England model articles for Academy Trusts (the "Company") where the Church is in a minority (i.e. "VC" model)

- 96 Any bank account in which any money of the Company is deposited shall be operated by the Directors in the name of the Company. All cheques and orders for the payment of money from such an account shall be signed by at least two signatories authorised by the Directors.

DIRECTORS' AND MEMBERS' CONFLICTS OF INTEREST

- 97 Any Director who has or can have any direct or indirect duty or personal interest (including but not limited to any Personal Financial Interest) which conflicts or may conflict with his or her duties as a Director shall disclose that fact to the Directors as soon as he or she becomes aware of it. A Director must absent himself or herself from any discussions of the Directors in which it is possible that a conflict will arise between his or her to act solely in the interests of the Company (including fulfilling its charitable objects) and any duty or personal interest (including but not limited to any Personal Financial Interest).
- 98 For the purpose of Article 97, a Director has a Personal Financial Interest if that interest is in respect of the employment or remuneration of, or the provision of any other benefit to, that Director as permitted by and as defined by Articles 6.5 - 6.9.
- 98A The Diocesan Board of Education shall not be deemed to have a conflict of loyalty or interest arising from its connection with the Church of England or its duty and functions under the Measure and no Director appointed by them shall be deemed to have a conflict of loyalty arising from their connection with the Church of England.
- 98B If otherwise than as set out in Article 98A a conflict of interests arises for a Director because of a duty of loyalty owed to another organisation or person and the conflict is not authorised by virtue of any other provision in these Articles, the unconflicted Directors may authorise such a conflict of interests where the following conditions apply:
- (a) the conflicted Director is absent from the part of the meeting at which there is discussion of any arrangement or transaction affecting that other organisation or person;
 - (b) the conflicted Director does not vote on any such matter and is not to be counted when considering whether a quorum of Directors is present at the meeting; and
 - (c) the unconflicted Directors consider it is in the interests of the Company to authorise the conflict of interests in the circumstances applying.

In this Article a conflict of interests arising because of a duty of loyalty owed to another organisation or person only refers to such a conflict which does not involve a direct or indirect benefit of any nature to a Director or to a connected person.

MINUTES OF DIRECTORS' MEETINGS

- 99 The minutes of the proceedings of a meeting of the Directors shall be drawn up and entered into a book kept for the purpose by the person acting as Clerk for the purposes of the meeting; and shall be signed (subject to the approval of the Directors) at the same or next subsequent meeting by the person acting as chair thereof.

COMMITTEES

- 100 Subject to these Articles, the Directors:

- (a) may appoint committees to be known as Local Governing Bodies for each Academy that is not a Church of England Academy (and the same Local Governing Body may be appointed for more than one such Academy), and shall appoint committees to be known as Local Governing Bodies for each Church of England Academy (and the same Local Governing Body may be appointed for more than one Church of England Academy) provided that the same Local Governing Body may not be appointed for a mix of Church of England Academies and Academies that are not Church of England Academies; and
 - (b) may establish any other committee.
- 101 Subject to these Articles, the constitution, membership and proceedings of any committee shall be determined by the Directors. The establishment, terms of reference, constitution and membership of any committee of the Directors shall be reviewed at least once in every 12 months. The membership of any committee of the Directors may include persons who are not Directors, provided that (with the exception of the Local Governing Bodies) a majority of members of any such committee shall be Directors. Except in the case of a Local Governing Body, no vote on any matter shall be taken at a meeting of a committee of the Directors unless the majority of members of the committee present are Directors.
- 101A The Directors shall ensure that any Local Governing Body shall include at least two Parent Local Governors
- 101B The Directors shall ensure that any Local Governing Body constituted:
 - (a) in respect of a Church of England Academy, or a number of Church of England Academies, the Diocesan Board of Education shall be entitled to appoint up to 25% of its members, and that all its members shall sign an undertaking to the Diocesan Board of Education to uphold the designated religious character of the said Church of England Academy/Academies.
 - (b) in respect of an Academy that is not a Church of England Academy, or in respect of a number of Academies that do not include a Church of England Academy, is appointed by the Directors taking into account the needs of the Academy/Academies and recognises and supports the individual ethos of the said Academy/Academies.
- 102 Not used.
- 103 All members of a Local Governing Body shall upon their appointment or election, and before exercising any duties as a member of the Local Governing Body, give a written undertaking to the Directors, and for members of a Local Governing Body appointed in relation to one or more Diocesan Schools the Trustees and the Diocesan Board of Education, to uphold the Object of the Company. If they refuse to give such an undertaking they shall immediately be disqualified from holding office.
- 104 The functions, duties and proceedings of the Local Governing Bodies or committees shall be subject to regulations made by the Directors from time to time. Local Governing Bodies may also be established solely for the purpose of fulfilling an advisory function to the board of Directors.

DELEGATION

- 105 The Directors may delegate any of their powers and functions (including the power to sub-delegate) to any Director, committee (including any Local Governing Body), the Chief

Executive Officer, the Principals or any other holder of an executive office. Any such delegation shall be made in writing and subject to any conditions the Directors may impose, and may be revoked or altered.

- 105A A Director, committee (including any Local Governing Body), the Chief Executive Officer or any other holder of an executive office to whom a power or function of the Directors is delegated under Article 105 may further sub-delegate those powers or functions (or any of them) to a further person. Where any power or function of the Directors is sub-delegated by any person to whom it has been delegated, that person must inform the Directors as soon as reasonably practicable which powers and functions have been further delegated and to whom, and any such sub-delegation shall be made subject to any conditions the Directors may impose, and may be revoked or altered by the Directors.
- 106 Where any power or function of the Directors has been exercised by any committee (including any Local Governing Body), any Director, the Chief Executive Officer, the Principals, any other holder of an executive office, or a person to whom a power or function has been sub-delegated under Article 105A, that person or committee shall report to the Directors in respect of any action taken or decision made with respect to the exercise of that power or function at the meeting of the Directors immediately following the taking of the action or the making of the decision.

CHIEF EXECUTIVE OFFICER, PRINCIPALS AND STAFF

- 107 The Directors, having consulted with the Diocesan Corporate Member and having made use of any relevant powers under section 124AA of the School Standards and Framework Act 1998 shall appoint the Chief Executive Officer. Subject to Article 105 the Directors may delegate such powers and functions as they consider are required by the Chief Executive Officer and the Principals for the internal organisation, management and control of the Academies (including the implementation of all policies approved by the Directors and for the direction of the teaching and curriculum at the Academies).
- 107A The Directors shall appoint the Principal of each Academy. In respect of the appointment of the Principal of any Academy that had immediately prior to conversion been a Voluntary Controlled school as defined by the Education Acts, the Directors may only appoint with the involvement and consent of the Diocesan Director of Education and having made use of their powers under s124AA of the School Standards and Framework Act 1998 or under the Relevant Funding Agreement in respect of those Church of England Academies.

MEETINGS OF THE DIRECTORS

- 108 Subject to these Articles, the Directors may regulate their proceedings as they think fit.
- 109 The Directors shall hold at least three meetings in every school year. Meetings of the Directors shall be convened by the Clerk. In exercising his or her functions under this Article the Clerk shall comply with any direction:
- (a) given by the Directors; or
 - (b) given by the Chair or, in his or her absence or where there is a vacancy in the office of Chair, the Vice-Chair, so far as such direction is not inconsistent with any direction given as mentioned in (a) above.

Church of England model articles for Academy Trusts (the "Company") where the Church is in a minority (i.e. "VC" model)

- 110 Any three Directors may, by notice in writing given to the Clerk, requisition a meeting of the Directors; and it shall be the duty of the Clerk to convene such a meeting as soon as is reasonably practicable.
- 111 Each Director shall be given at least seven clear days before the date of a meeting:
- (a) notice in writing thereof, signed by the Clerk, and sent to each Director at the address provided by each Director from time to time; and
 - (b) a copy of the agenda for the meeting,
- provided that where the Chair or, in his or her absence or where there is a vacancy in the office of Chair, the Vice Chair, so determines on the ground that there are matters demanding urgent consideration, it shall be sufficient if the written notice of a meeting, and the copy of the agenda thereof are given within such shorter period as he or she directs.
- 112 The convening of a meeting and the proceedings conducted thereat shall not be invalidated by reason of any individual not having received written notice of the meeting or a copy of the agenda thereof.
- 113 A resolution to rescind or vary a resolution carried at a previous meeting of the Directors shall not be proposed at a meeting of the Directors unless the consideration of the rescission or variation of the previous resolution is a specific item of business on the agenda for that meeting.
- 114 A meeting of the Directors shall be terminated forthwith if:
- (a) the Directors so resolve; or
 - (b) the number of Directors present ceases to constitute a quorum for a meeting of the Directors in accordance with Article 117, subject to Article 119.
- 115 Where in accordance with Article 114(b) a meeting is not held or is terminated before all the matters specified as items of business on the agenda for the meeting have been disposed of, a further meeting shall be convened by the Clerk as soon as is reasonably practicable, but in any event within seven days of the date on which the meeting was originally to be held or was so terminated.
- 116 Where the Directors resolve in accordance with Article 114(a) to adjourn a meeting before all the items of business on the agenda have been disposed of, the Directors shall before doing so determine the time and date at which a further meeting is to be held for the purposes of completing the consideration of those items, and they shall direct the Clerk to convene a meeting accordingly.
- 117 Subject to Article 119 the quorum for a meeting of the Directors, and any vote on any matter thereat, shall be any three Directors, or, where greater, any one third (rounded up to a whole number) of the total number of Directors holding office at the date of the meeting, who are in each case present at the meeting and entitled to vote on the matters to be resolved.
- 118 The Directors may act notwithstanding any vacancies in their number, but, if the numbers of Directors is less than the number fixed as the quorum, the continuing Directors may act only for the purpose of filling vacancies or of calling a General Meeting.
- 119 The quorum for the purposes of:

Church of England model articles for Academy Trusts (the "Company") where the Church is in a minority (i.e. "VC" model)

- (a) any vote on the removal of a Director in accordance with Article 66; and
- (b) any vote on the removal of the Chair in accordance with Articles 90 and 91,

shall be any two-thirds (rounded up to a whole number) of the persons who are at the time Directors present at the meeting and entitled to vote on those respective matters.

120 Subject to these Articles, every question to be decided at a meeting of the Directors shall be determined by a majority of the votes of the Directors present and voting on the question. Every Director shall have one vote.

121 Subject to Articles 117 - 119, where there is an equal division of votes, the chair of the meeting shall have a casting vote in addition to any other vote he or she may have.

122 The proceedings of the Directors shall not be invalidated by

- (a) any vacancy among their number; or
- (b) any defect in the election, appointment or nomination of any Director.

123 A resolution in writing, signed by all the Directors entitled to receive notice of a meeting of Directors or of a committee of Directors, shall be valid and effective as if it had been passed at a meeting of Directors or (as the case may be) a committee of Directors duly convened and held. Such a resolution may consist of several documents in the same form, each signed by one or more of the Directors.

124 Subject to Article 125, the Directors shall ensure that a copy of:

- (a) the agenda for every meeting of the Directors;
- (b) the draft minutes of every such meeting, if they have been approved by the person acting as chair of that meeting;
- (c) the signed minutes of every such meeting; and
- (d) any report, document or other paper considered at any such meeting,

are, as soon as is reasonably practicable, made available at every Academy to persons wishing to inspect them.

125 There may be excluded from any item required to be made available in pursuance of Article 124, any material relating to:

- (a) a named Teacher or other person employed, or proposed to be employed, at any Academy;
- (b) a named pupil or named student at, or candidate for admission or referral to, any Academy; and
- (c) any matter which, by reason of its nature, the Directors are satisfied should remain confidential.

126 Any Director shall be able to participate in meetings of the Directors by telephone or video conference provided that:

- (a) he or she has given notice of his or her intention to do so detailing the telephone number on which he or she can be reached and/or appropriate details of the video conference facilities which he or she shall be using at least 48 hours before the meeting; and
- (b) the Directors have access to the appropriate equipment.

If after all reasonable efforts it does not prove possible for the person to participate by telephone or video conference the meeting may still proceed with its business provided it is otherwise quorate.

PATRONS AND HONORARY OFFICERS

- 127 The Directors may from time to time appoint any person whether or not a Member to be a patron of the Company or to hold any honorary office and may determine for what period he or she is to hold such office.

THE SEAL

- 128 The seal, if any, shall only be used by the authority of the Directors or of a committee of Directors authorised by the Directors. The Directors may determine who shall sign any instrument to which the seal is affixed and unless otherwise so determined it shall be signed either by a Director and by the Clerk or by a second Director.

ACCOUNTS

- 129 Accounts shall be prepared in accordance with the relevant statement of recommended practice published by the Charity Commission from time to time (the "Statement of Recommended Practice") as if the Company was a non-exempt charity and Parts 15 and 16 of the Companies Act 2006 and shall file these with the Secretary of State and the Principal Regulator by 31 December each Academy Financial Year.

ANNUAL REPORT

- 130 The Directors shall prepare the Company's Annual Report in accordance with the Statement of Recommended Practice as if the Company was a non-exempt charity and shall file these with the Secretary of State and the Principal Regulator by 31 December each Academy Financial Year.

ANNUAL RETURN

- 131 The Directors shall comply with their obligations under Part 24 of the Companies Act 2006 (or any statutory re-enactment or modification of that Act) with regard to the preparation of an annual return to the Registrar of Companies and will supply a copy of the confirmation statement to the Secretary of State and the Principal Regulator by 31 December each Academy Financial Year.

NOTICES

- 132 Any notice to be given to or by any person pursuant to these Articles (other than a notice calling a meeting of the Directors) shall be in writing or shall be given using electronic communications to an address for the time being notified for that purpose to the person

giving the notice. In these Articles, "address" in relation to electronic communications, includes a number or address used for the purposes of such communications.

- 133 A notice may be given by the Company to a Member either personally or by sending it by post in a prepaid envelope addressed to the Member at his or her registered address or by leaving it at that address or by giving it using electronic communications to an address for the time being notified to the Company by the Member. A Member whose registered address is not within the United Kingdom and who gives to the Company an address within the United Kingdom at which notices may be given to him or her, or an address to which notices may be sent using electronic communications, shall be entitled to have notices given to him or her at that address, but otherwise no such Member shall be entitled to receive any notice from the Company.
- 134 A Member present, either in person or by proxy, at any meeting of the Company shall be deemed to have received notice of the meeting and, where necessary, of the purposes for which it was called.
- 135 Proof that an envelope containing a notice was properly addressed, prepaid and posted shall be conclusive evidence that the notice was given. Proof that a notice contained in an electronic communication was sent in accordance with guidance issued by the Institute of Chartered Secretaries and Administrators shall be conclusive evidence that the notice was given. A notice shall be deemed to be given at the expiration of 48 hours after the envelope containing it was posted or, in the case of a notice contained in an electronic communication, at the expiration of 48 hours after the time it was sent.

INDEMNITY

- 136 Subject to the provisions of the Companies Act 2006 and Article 6.3 every Director or other officer or auditor of the Company shall be indemnified out of the assets of the Company against any liability incurred by him or her in that capacity in defending any proceedings, whether civil or criminal, in which judgment is given in favour or in which he or she is acquitted or in connection with any application in which relief is granted to him or her by the court from liability for negligence, default, breach of duty or breach of trust in relation to the affairs of the Company.

RULES

- 137 The Directors may from time to time make such rules or bye laws as they may deem necessary or expedient or convenient after consultation with the Diocesan Corporate Member for the proper conduct and management of the Company and for the purposes of prescribing classes of and conditions of membership, and in particular but without prejudice to the generality of the foregoing, they may by such rules or bye laws regulate:
- (a) the setting aside of the whole or any part or parts of the Company's premises at any particular time or times or for any particular purpose or purposes;
 - (b) the procedure at General Meetings and meetings of the Directors and committees of the Directors and meetings of the Local Governing Bodies in so far as such procedure is not regulated by the Articles; and
 - (c) generally, all such matters as are commonly the subject matter of company rules.

Church of England model articles for Academy Trusts (the "Company") where the Church is in a minority (i.e. "VC" model)

- 138 The Company in general meeting shall have power to alter, add or to repeal the rules or bye laws, but only having consulted the Diocesan Corporate Member. Provided that no rule or bye law shall be inconsistent with, or shall affect or repeal anything contained in the Articles.

AVOIDING INFLUENCED COMPANY STATUS

- 139 Notwithstanding the number of Members from time to time, the maximum aggregate number of votes exercisable by Local Authority Associated Persons shall never exceed 19.9% of the total number of votes exercisable by Members in General Meeting and the votes of the other Members having a right to vote at the meeting will be increased on a pro-rata basis.
- 140 No person who is a Local Authority Associated Person may be appointed or elected as a Director if, once the appointment or election had taken effect, the number of Directors who are Local Authority Associated Persons would represent 20% or more of the total number of Directors. Upon any resolution put to the Directors, the maximum aggregate number of votes exercisable by any Directors who are Local Authority Associated Persons shall represent a maximum of 19.9% of the total number of votes cast by the Directors on such a resolution and the votes of the other Directors having a right to vote at the meeting will be increased on a pro-rata basis.
- 141 No person who is a Local Authority Associated Person is eligible to be appointed or elected to the office of Director unless his or her appointment or election to such office is authorised by the local authority to which he or she is associated.
- 142 If at the time of either his or her becoming a Member or his or her first appointment or election to office as a Director any Member or Director was not a Local Authority Associated Person but later becomes so during his or her membership or tenure as a Director he or she shall be deemed to have immediately resigned his or her membership and/or resigned from his or her office as a Director as the case may be.
- 143 If at any time the number of Directors or Members who are also Local Authority Associated Persons would (but for Articles 139 - 142 inclusive) represent 20% or more of the total number of Directors or Members (as the case may be) then a sufficient number of the Directors or Members (as the case may be) who are Local Authority Associated Persons shall be deemed to have resigned as Directors or Members (as the case may be) immediately before the occurrence of such an event to ensure that at all times the number of such Directors or Members (as the case may be) is never equal to or greater than 20% of the total number of Directors or Members (as the case may be). Directors or Members (as the case may be) who are Local Authority Associated Persons shall be deemed to have resigned in order of their appointment or election date the most recently appointed or elected resigning first.
- 144 The Members will each notify the Company and each other if at any time they believe that the Company or any of its subsidiaries has become subject to the influence of a local authority (as described in section 69 of the Local Government and Housing Act 1989).
