- B. The sum of EIGHT THOUSAND SIX HUNDRED SEVENTY DOLLARS (\$8,670.00) being the amount deemed required for the payment of employer contributions of the Lewistown Carnegie Public Library District, to the Social Security Fund.
- C. The sum of ELEVEN THOUSAND THREE HUNDRED DOLLARS (\$11,300.00) being the amount deemed required for the payment of employer contributions of the Lewistown Carnegie Public Library District, to the Illinois Municipal Retirement Fund.
- D. The sum of TWO THOUSAND ONE HUNDRED NINETY DOLLARS (\$2,190.00) being the amount deemed required for the payment of the professional opinion of an accountant and other auditing expenses from an Audit Fund.
- E. The sum of FORTY-FIVE THOUSAND ONE HUNDRED FIFTY DOLLARS (\$45,150.00) being the amount deemed required for the purpose of payment of premiums due for public liability insurance, property
