WHEREAS, said Annual Budget and Appropriation Ordinance was

duly published as provided by law after its passage; NOW, THEREFORE,
BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
LEWISTOWN CARNEGIE PUBLIC LIBRARY DISTRICT, IN THE COUNTY OF EULTON,
STATE OF ILLINOIS, as follows:

Section 1: That the total sum of TWO HUNDRED THIRTY-FIVE
THOUSAND EIGHT HUNDRED SEVENTY-FIVE DOLLARS (\$235,875.00) composed
as follows, be and the same is hereby levied and assessed upon and
against all taxable property within this Library District
according to the value as established and ascertained for State and
County purposes for the fiscal year beginning July 7, 2025 and ending
June 30, 2026 and the Board of Trustees of the Lewistown Carnegie
Public Library District having the 18th day of August, 2025 duly passed
and adopted the Annual Budget and Appropriation Ordinance for the
fiscal year beginning July 1, 2025 and ending June 30, 2026 and said
Ordinance having been published in a

newspaper of general circulation within this Library District. This Board finds that the specific purposes and specific amounts provided for in said Annual Budget and Appropriation Ordinance, a copy of which is attached hereto and by this reference made a part hereof, are required to be levied for the necessary purposes of Lewistown Carnegie Public Library District:

A. The sum of ONE HUNDRED FORTY-NINE THOUSAND SIXTY-FIVE DOLLARS (\$149,065.00) being the amount deemed required for the necessary Corporate purposes of the Lewistown Carnegie Public Library District.

B. The sum of EIGHT THOUSAND SIX HUNDRED SEVENTY DOLLARS (\$8,670.00) being the amount deemed required for the payment of employer contributions of the Lewistown Carnegie Public Library District, to the Social Security Fund.

C. The sum of ELEVEN THOUSAND THREE HUNDRED DOLLARS (\$11,300.00) being the amount deemed required for the payment of employer contributions of the Lewistown Carnegie Public Library District, to the Illinois Municipal Retirement Fund.

D. The sum of TWO THOUSAND ONE HUNDRED NINETY DOLLARS (\$2,190.00) being the amount deemed required for the payment of the professional opinion of an accountant and other auditing expenses from an Audit Fund.

E. The sum of FORTY-FIVE THOUSAND ONE HUNDRED FIFTY DOLLARS (\$45,150.00) being the amount deemed required for the purpose of payment of premiums due for public liability insurance, property

C. The Sum of ELEVEN THOUSAND THREE HUNDRED DOLLARS (\$11,300.00) being the amount deemed required for the payment of employer contributions of the Lewistown Carnegie Public Library District, to the Illinois Municipal Retirement Fund.

D. The sum of TWO THOUSAND ONE HUNDRED NINETY DOLLARS (\$2,190.00) being the amount deemed required for the professional opinion of an accountant and expenses from an Audit Fund. the payment of other auditing

E. The sum of FORTY-FIVE THOUSAND ONE HUNDRED FIFTY DOLLARS (\$45,150.00) being the amount deemed required for the purpose of payment of premiums due for public liability insurance, property

damage (fire) insurance, legal fees for defending or otherwise protecting itself against liability, risk management and loss control programs as provided by ^{45 ILCS 70/9-101}, of the Lewistown Carnegie Public Library District.

F. The Sum of NINETEEN THOUSAND FIVE HUNDRED DOLLARS (\$19,500.00) being the amount deemed required for repairs and alterations of library buildings and Maintenance Fund of the
