 - ** Updates should be posted by this Friday following the winter break / holiday for those that submitted clarifications
- B. Utilize Google Form to submit any questions - must receive by noon on Monday mornings
 - ** Jump clarifications tend to be the popular question submitted. Remember that teams only need 3 jumps vs the 4 from last year. In a quad jump - the 4th jump goes to skill utilization
 - ** Lance added that a triple jump combo should be high level 4 rubric range
 - ** Kara asked if jump clarifications can be added to the rubric in black and white. North region vs south region is quite different. Would be nice to see the consistency amongst officials. John said he would reach out to clinicians. Lance added in feedback about how you need to be consistent with yourself. Ask yourself - what is your 10 as an official? John double checked the IHSA cheer menu page that clarifications were displayed to reiterate what classifies a high level 4 in that rubric range.
 - ** From a tech perspective - performance based legality (PBL) is not to be used for a warning on the tech side. Warnings should be issued under the "major" tab.
 - ** Joey asked for some clarification in regards to what is minor vs major with PBL

 - ** Would like organization to continue to flourish, so please take into consideration if you are interested in a board position for the next year
