- Process validation is the collection and validation of data, from the process design stage throughout production, establishing scientific evidence that a process is able to consistently deliver quality products.
- It is commonly used in industries such as pharmaceutical validation and medical device validation.
- There are three main stages of process validation:

- Stage 1 - Process Design
 - This stage is when the commercial manufacturing process is defined
- Stage 2 - Process Qualification
 - The process design is evaluated and confirmed for meeting demands of reproducibility.
- Stage 3 - Continued Process Verification
 - There is ongoing assurance is conducted during routine production to ensure the process remains in control.
- Additionally there are four types of process validation
 - Prospective Validation/ Premarket Validation
 - Establishing evidence prior to the process implementation that a system does as it should based on pre planned protocols.
 - Retrospective Validation
 - Used for facilities, processes, and process controls in operation use that have experienced a formally documented validation process.
 - Concurrent Validation
 - Used for determining evidence that a facility and processes do as they say, based on the information generated from imputation of the process.
 - Revalidation
 - Repeating original validation and involves reviewing existing performance data.
