Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

The City Government of Antipolo will hold a Pre-Bid Conference on **March 14, 2024** at **10:00am**, which shall be open to all interested parties.

Bids must be delivered to the address below on or before **March 26, 2024 until 1:00pm**. All Bids must be accompanied by a bid security in the amount equal to the percentage of the Approved Budget for the Contract in accordance with the form of bid security prescribed herein.
